The Treasury Forfeiture Fund was established in 1992 as a special revenue account consisting of the forfeited assets of criminal enterprises. Deposits are made into the fund by a number of federal law enforcement agencies resulting from successful action against criminal organizations, and the fund's assets are used to further disrupt and dismantle criminal enterprises. The Joint Operations/State and Local Overtime (SLOT) program allows the Treasury Forfeiture Fund (TFF) to reimburse State and local agencies for overtime used for joint investigations and operations with the U.S. Department of Homeland Security.

Dear District Attorney Ogg:

The Harris County District Attorney's Office (HCDAO) is a valued partner with U.S. Immigration and Customs Enforcement, Homeland Security Investigations (HSI) Joint Operations Program which allows HSI to reimburse your office for certain approved expenses incurred in support of our shared law enforcement goals.

HSI's Joint Operations Program is funded by the Treasury Forfeiture Fund and all requested reimbursements must be directly related to expenses incurred as a result of your participation with HSI. It should be further noted that the incurred expenses will be reimbursed after payment of initial expenses. The reimbursements will come from the Treasury Forfeiture Fund and will be distributed in the following category and amount:

Harris County District Attorney's Office (CNET) Overtime: \$4,000.00

This allotment represents the total amount of funding being provided to your office for FY 2022 that commenced on October 1, 2021 and will end on September 30, 2022. One of the most important aspects of managing this program involves the timely submission and processing of your agency's reimbursement packages. To ensure compliance with fiscal law and regulations, **it is critical that your agency submit all reimbursement packages to your HSI point of contact within 30 calendar days after the end of the preceding month.** Packages received after this time will cause a delay in reimbursement to your office.
