

Re: American Rescue Plan Act (ARPA) Monthly Report

Since our last report, Commissioners Court has approved the following investments and agreements across the ARPA Portfolio:

HEALTH	Reproductive Health Access Fund: Approval of 11 amendments with each subrecipient, updating the Federal Award Identification tables and budgets with no increase in total contract amount. Neighborhood Nuisance Abatement: Approval to abate in Precincts 1, 2, 3, and 4 and approval of a structural abatement agreement renewal for RNDI Companies for the period of June 1, 2025 - May 31, 2026 at a cost of \$20,000.
HOUSING	Affordable Housing: Multifamily Development: Approval to execute an agreement to grant up to \$1,300,000 of FLEX Funds to the Harris County Housing Finance Corporation to pay for essential professional services and operational support for initiatives originally supported with ARPA funds.
Jobs and Education	Early Childhood Initiatives: Home Grown: Building Comprehensive Networks (BCN) Year 1: Approval of an amendment to an agreement with the Health Federation of Philadelphia to extend the grant end date to May 31, 2025 for the Home Grown: Building Comprehensive Networks (Year 1) project.
County Ops	FLEX Fund: Approval to raise the ceiling of the FLEX Fund by an additional \$200 million to a total of \$315 million to continue supporting projects aligned with ARPA priority outcomes.

A total of \$983.1 million has been allocated to date toward pandemic recovery programs in the ARPA and FLEX portfolios.

NEW INVESTMENTS & AGREEMENTS

HEALTH

Reproductive Health Access Fund:

Commissioners Court approved amendments with the 11 subrecipients to update the Federal Award Identification tables and budgets with no increase in total contract amount.

Neighborhood Nuisance Abatement

Commissioners Court approved abatements in Precincts 1, 2, 3, and 4 and approved renewal agreement with RNDI Companies for the period of June 1, 2025 - May 31, 2026 at a cost of \$20,000 for structural abatement services.

HOUSING

Affordable Housing: Multi-Family Development

Commissioners Court approved the execution of 381 agreement to grant up to \$1.3 million of FLEX Funds to the Harris County Housing Finance Corporation to pay for essential professional services and operational support for initiatives originally supported with ARPA funds.

Homelessness

Commissioners Court approved the amendment to an agreement with SEARCH Homeless Services to clarify the Texas Prevailing Wage Requirements. The amendment allows the subrecipient to use the award for purchase of materials only.

Jobs & Education

Early Childhood Initiatives: Home Grown: Building Comprehensive Networks (BCN) Year 1

Commissioners court approved an amendment to an agreement with the Health Federation of Philadelphia to extend the grant end date to May 31, 2025 for the Home Grown: Building Comprehensive Networks (Year 1) project.

Early Childhood Initiatives: Home Grown: Building Comprehensive Networks (BCN) Year 2

Commissioners court accepted grant funds in the amount of \$100,000, with no required match, from the Health Federation of Philadelphia for Home Grown: Building Comprehensive Networks (Year 2) Implementation.

County Operations

County Ops

Commissioners Court approved an increase of the maximum budget of the FLEX Fund (1040) from \$200 million to \$315 million to continue supporting projects aligned with ARPA priority outcomes. Harris County will be able to expend ARPA funds on immediately eligible costs, making General Fund budget available in the FLEX Fund 1040 to continue funding the projects as currently approved.

Justice & Safety

Court Backlog

Commissioners Court approved a FLEX Fund allocation of up to \$1.1 million for the District Courts, \$280,534 for the District Clerk, \$1.2 million for the Sheriff, and \$306,408 for Pretrial Services to continue Court Backlog

initiatives through FY25. Since must be obligated by December 31, 2024, and expended by December 31, 2026. Program budgets encumbered by a contract, purchase order, or full-time employee (FTE) are reported as obligated. However, since these departments had vacancies on 12/31/2024 this allows those roles to be filled.

ACTIVE PROJECTS

HEALTH PORTFOLIO

Behavioral Health (BH)

Behavioral Health

Harris County seeks to enhance BH educational tracks and develop a pipeline to increase the number of culturally and linguistically competent BH providers. This program also seeks to expand services in socially vulnerable neighborhoods for youth and supports overdose prevention initiatives and access to treatment.

The Behavioral Health Counseling for Youth & Families is administered by four subrecipients:

- Communities in Schools (CIS) provides school-based mental health services delivered by licensed and qualified subcontractors and supports students through group counseling.
- Covenant House Texas provides mental health services to youths, focusing on homeless youths and young parents, LGBTQ+ youths, and victims of human trafficking and domestic or dating violence. Program completed on 11/14/2024.
- Houston Area Women's Center (HAWC) provides comprehensive services to survivors of family violence in their communities, including individual and group counseling.
- Tilman J. Fertitta College of Medicine provides outpatient mental health services for children and families, school-based and in-home care coordination, and training opportunities for graduate students.

The **Behavioral Health Substance Abuse Treatment and Overdose Prevention program** is administered by four subrecipients:

- Cenikor Foundation is expanding access to MAT services, peer recovery support, and recovery housing.
- The Council on Recovery provides outreach, screening, assessment, and referral (OSAR) services, as well as training on overdose prevention and the use of naloxone. Program completed on 1/31/2025.
- Houston Recovery Center provides prevention education and behavioral health referrals, including access to Medication-Assisted Treatment (MAT) and naloxone to prevent opioid overdoses. Program completed on 1/31/2025.
- Santa Maria Hostel, in partnership with Baylor College of Medicine, implements the I-CARE Clinic to expand access to physical healthcare, psychiatric care, and substance use disorder (SUD) treatment.

The **Behavioral Health Workforce program** is administered by three subrecipients:

- Meadows Mental Health Policy Institute (MMHPI), with support from the Lucine Center, delivers trauma- and grief-informed training to community- and school-based clinicians.
- The Network of Behavioral Health Providers (NBHP) trains peer support counselors and community health workers, develops a pipeline of educational and experiential opportunities, provides scholarships for students, and offers outcomes-based reimbursements for community health workers.
- The Montrose Center provides development and internship opportunities, recruiting and retention incentives for licensed therapists, and training in advanced marriage and family therapy practices.

Clean Streets, Safe Neighborhoods

Community Engaged Design

Clean Streets, Safe Neighborhoods is a crime prevention and neighborhood safety program that uses data to target Harris County neighborhoods where underinvestment in neighborhood infrastructure could be driving violent crime. The program aims to improve street lighting, sidewalks, and green spaces, and create opportunities for civic artwork. A Neighborhood Prioritization Index was utilized to identify priority communities based on the Center for Disease Control and Prevention's Social Vulnerability Index, violent crime indicators, and infrastructure indicators. Several of the projects within the priority neighborhoods were identified based on surveys and studies gathering feedback from the community regarding neighborhood improvement initiatives. These studies identified areas with high pedestrian traffic and few sidewalks, poorly lit sidewalks and pedestrian paths, areas of high temperatures, and many other areas for neighborhood improvements. Harris County Precincts are working with the Engineering Department to coordinate on program design, construction, and maintenance plans.

Neighborhood Nuisance Abatement

The ARPA Neighborhood Nuisance Abatement (NNA) project has been established to complement current NNA efforts in Harris County being implemented by the Harris County Public Health Department. NNA is an initiative focused on reducing crime and improving public health in Harris County's most impacted communities. The program aims to decrease crime and improve public health through proactive efforts, such as securing or demolishing unsafe structures, removing rubbish, securing abandoned pools, removing weeds to prevent pest infestation, and other abatement efforts.

Coordinated Care

ACCESS Harris

ACCESS (Accessing Coordinated Care and Empowering Self Sufficiency) Harris County is an integrated care model that addresses the root causes of poor health and life outcomes by holistically addressing the social determinants of health. Using a coordinated care approach, ACCESS Harris improves the health, well-being, sustained recovery, and self-sufficiency of the County's most vulnerable residents by not just focusing on guiding them into the social safety net, but also enabling them to get out of it. ACCESS Harris County focuses on delivering intensive wraparound services to individuals in need across the County through a no-wrong-door approach. This safety net includes providers that organize and deliver a significant level of health care and other needed services to uninsured, Medicaid, and other vulnerable patients.

Environmental Health: Lead

Lead Abatement and Prevention

The Lead Abatement and Prevention Program mitigates lead poisoning in Harris County by assisting in the abatement of lead-based paint hazards in child-occupied facilities and owner or renter-occupied, single-family housing units for the purpose of providing safe and decent housing for low- and moderate-income households. Additionally, the program is committed to reducing lead poisoning in at-risk individuals, including pregnant women and children under the age of six years old in communities throughout Harris County. Lead poisoning caused by elevated blood lead levels (EBLLs) is a serious but preventable health threat to both children and adults in the United States. Primary (education) and secondary (lead screening) prevention of lead exposure is the most effective approach to reducing the risk of lead poisoning in children. The abatement program focuses on residential buildings and child-occupied facilities, like daycares and preschools, constructed before 1978. The Lead Abatement and Prevention Program operates mobile testing sites at schools and community events to increase testing among pregnant women and children under the age of six. Mobile testing sites increase awareness of lead poisoning and address concerns about access to transportation to testing sites in impacted communities.

Food and Nutrition

Food & Nutrition Awards

The ARPA Food & Nutrition Program aims to address food insecurity in Harris County by increasing access to healthy foods and strengthening our local food and nutrition infrastructure. This program is improving food distribution infrastructure, providing food and nutrition services to individuals disproportionately impacted by the pandemic or living in food deserts, and providing small capacity-building grants to hyperlocal food providers. These activities will enable partnerships across entities and to increase produce availability in food deserts.

The Food & Nutrition program is administered by four subrecipients:

- Common Market provides boxes of fresh food for distribution by food banks and community organizations and offers discounts on fresh food to organizations serving low-income families. Program completed on 1/31/2025
- **Houston Food Bank** provides grants to partners for logistics software, walk-in coolers, small equipment, and labor.
- **Small Places** produces and distributes fresh fruits and vegetables in an urban farm and provides nutrition education through field trips, cooking classes, and recipe distribution.
- **Urban Harvest** managed and hosted recurring mobile or pop-up markets and provided nutrition education. Program completed on 5/31/2024.

Harris Health

Food Farmacy

Harris Health's Food Rx program proactively embeds a population health approach as part of the standard of care for chronic disease management, strategically intervening with patients with expressed social needs and known health risks in order to improve their health outcomes. The program addresses health-related social needs, like food insecurity, poor nutritional knowledge, and lack of access to culinary education, that are prevalent in vulnerable populations and tied to poor health outcomes. Harris Health's Food Farmacies are currently at two family practice clinics and the LBJ Hospital, serving adult patients expressing food insecurity and providing a more intensive intervention for those with Type 2 diabetes.

GI Lab

Harris Health's existing gastroenterology labs are at maximum capacity and Harris Health has a significant number of patients waiting for colonoscopy procedures at any given time. Delays in diagnosis can result in poor outcomes of an otherwise treatable cancer. Ultimately, it is the goal of Harris Health to reduce the number of colorectal cancer diagnoses through prevention, and to reduce the severity of colorectal cancer diagnoses. This program now allows Harris Health to open an outpatient gastroenterology lab at Quentin Mease Health Center and create additional capacity for colonoscopy procedures. The new lab will increase availability of appointments and will be located directly on a bus route, making access easier and minimizing transportation burdens for those patients without a personal vehicle.

Healthcare Access

Chronic Disease Prevention (CDP)

The Chronic Disease Prevention (CDP) program will expand access to programming and education to reduce the prevalence and impact of chronic disease-causing risk behaviors in Harris County. This

includes offering clinical services, education on tobacco and vaping prevention and cessation, nutrition and physical activity, diabetes prevention, and community incentives.

The mission of this program is to improve the quality of life for Harris County residents while reducing the number of chronic disease-related deaths through targeted and long-term action plans. The CDP program partners with local schools, community centers, and other community-based programs to provide class-based curriculums for Harris County residents to provide information and resources about the risks associated with common chronic diseases as well as strategies for prevention.

Program goals include:

- Reducing the prevalence of chronic disease-causing risk behaviors
- Reaching a diverse range of Harris County residents, including low-income, minority, and high-risk individuals
- Reducing the healthcare costs associated with chronic diseases.

Maternal and Child Health

The Maternal and Child Health (MCH) pilot program was developed to lessen the health disparities that impact Black women and their babies by increasing their ability to access and utilize quality care. The program provides direct assistance to at-risk, expecting families with a holistic approach to prenatal care, postpartum care, and infant-early child development. Working closely with a broad and diverse group of community partners, expecting families will have access to local organizations and programs specializing in maternal and child health. The program allows more Black mothers and their infants to enroll in available health coverage options, provides them with access to more prenatal and well-child visits, and provides home visits from educators and healthcare providers.

Reproductive Health Fund

The Harris County Reproductive Healthcare Access Fund provides funding to existing under-resourced health clinics and grassroots organizations to decrease the transmission of sexually transmitted infections, improve the overall health of people of reproductive age, and increase clinical services within Harris County zip codes with the highest Social Vulnerability Index (SVI) and uninsured rates. The fund aims to expand services and improve reproductive healthcare access in priority zip codes, increase utilization, and build capacity for reproductive healthcare organizations to educate, promote, and connect the community to reproductive healthcare services. This funding opportunity specifically targets entities at the local level to build on existing expertise and create sustainable operational improvements. The Harris County service area will also increase reproductive healthcare access by including service provision to uninsured residents at new clinics or mobile units.

The Reproductive Health Fund program is administered by twelve subrecipients:

- Harris County Public Health works on helping build capacity of clinical services and expand reproductive health education.
- Asians Against Domestic Abuse provides outreach and education to address domestic violence, mental health, and reproductive healthcare.
- East Harris County Empowerment Council provides outreach and education, including culturally sensitive and linguistically appropriate materials on reproductive health.

- Fundación Latinoamericana de Acción Social provides outreach and education to address behavioral health, substance use, and STI/HIV prevention.
- **Honeycomb Clinic** provides outreach and education on services offered in the community. Offers reproductive services and increase clinic capacity.
- **Mid-America Arts Alliance** provides outreach and education to address reproductive healthcare in the refugee community.
- Omar Welfare Association provides outreach and education to address reproductive healthcare in the refugee community.
- Rainbow Health provides outreach and education to address family planning, maternal health, reproductive rights, and health screenings.
- **The Brown Egg** provides outreach and education on culturally relevant materials on contraception, pregnancy prevention, cancer, STD/HIV, and overall reproductive health.
- Tony's Place provides outreach and education specific to LGBTQ+ individuals and community.
- **Vecino** increases utilization of reproductive health services, education and outreach through their health literacy program.
- Women Healing Empowering Women provides education and outreach to address reproductive healthcare.

HOUSING PORTFOLIO

Affordable Housing

Affordable Housing Admin

The Affordable Housing Roles will support the development and implementation of projects under the ARPA Affordable Housing Portfolio. The Affordable Housing Portfolio includes multi-family acquisitions and preservation for affordable rental housing, single-family acquisitions and preservation for resale to qualified homeowners, direct homeowner assistance and housing counseling and legal services. These resources are necessary to manage the substantial increase in activity that the investments will bring. The Assistant Director will lead program management, contract development and implementation, manage program performance metrics, and oversee four program managers. The program managers will design and implement Affordable Housing programs. Program managers will work in specific focus areas, such as new multi-family housing supply, new single family housing supply, multi-family housing preservation, and single-family housing preservation.

Single Family Reconstruction

The Single-Family Reconstruction Program will be solely administered by Harris County Housing and Community Development (HCD) to provide funding for the preservation of affordable single-family housing owned by LMI households residing in Harris County. This program has been designed to preserve affordable housing through the reconstruction of unsafe and uninhabitable homes into hazard-resilient and energy-efficient quality homes. The preservation of owner-occupied affordable housing allows LMI homeowners the ability to remain in their familiar neighborhoods and communities.

Single-Family Rehabilitation

The Single-Family Rehabilitation Program will be administered by the (HCD) with community-based non-profits serving as subrecipients who will deliver program services. This program has been designed to preserve affordable single-family housing owned by LMI households residing in Harris County by providing funds for specific rehabilitation services for single-family homes.

Single-Family Supply

The Harris County Housing and Community Development Department (HCD) will utilize a two-pronged approach to administer the ARPA Single Family Acquisition and Resale Program. Both programs will utilize the Community Land Trust Model to create affordable housing for low-income households. The two programs include the following:

- The Acquisition and Resale program HCD acquires primarily newly constructed single-family homes located in Harris County and resells to eligible low-income households.
- The Homebuyer Driven Program HCD assists low-income homebuyers in acquiring pre-existing or newly constructed single-family homes by providing a maximum of \$150,000 in financial assistance towards the purchase of a home.

Homeowner Assistance - Homeowner Preservation - Legal Assistance Program

Homeowner Preservation – Legal Assistance Program will address the heightened legal challenges and vulnerabilities faced by low-income homeowners in the aftermath of the pandemic. The economic repercussions of the pandemic placed many individuals at risk of foreclosure, clouded titles, and other legal issues related to homeownership. The program will seek to address these issues by providing legal guidance and assistance to the resolution of legal issues concerning their real property, thereby supporting homeowner preservation, and encouraging the development of generational wealth.

Homeowner Assistance - Sustainability Education and Counseling Services

The Sustainability Education & Counseling Program will address the urgent need for targeted support, counseling, and education to empower homebuyers and homeowners in navigating the complex landscape of

housing during these unprecedented times. The program will provide eligible homebuyers and homeowners with housing counseling and education to increase awareness of homeownership opportunities, including access to downpayment assistance programs, closing cost assistance programs, post-purchase counseling, financial management, mortgage default and foreclosure prevention counseling services, and home maintenance education.

Legal Aid & Evictions Services

Harris County seeks to maximize the impact of its COVID-19 rental assistance funding by investing in eviction defense legal services for low-income residents. Harris County has had an increased number of evictions, especially for non-payment of rent due to household financial losses related to the COVID-19 pandemic. Housing instability has lasting negative health and financial impacts on the families losing their homes as well as their communities. During the public health crisis and aftermath, the COVID-19 Eviction Defense Program will continue to support a network of housing legal service providers to meet increased demand through funding for attorneys, paralegals, intake staff, interpretation, community outreach, and programmatic costs associated with these services as well as those costs necessary to ensure the provision of this legal assistance safely in light of the public health and economic crisis. Period of performance extended to January 1, 2025 – June 30, 2025.

Eviction Appeal Support

Harris County not only experienced an increase in the number of evictions filed but also a significant increase in the number of eviction appeals filed in Civil Court. For comparison, in 2019 there were 3,853 eviction appeal cases filed, versus 5,785 eviction appeal cases filed in 2023. Similarly, the days to disposition increased from 40 days in 2019 to 63 days in 2023. The increase in days to disposition can cause significant financial hardship for both tenants and landlords. A tenant must pay at least one month of rent and continue paying at the usual rate until disposition. If they are unable to pay, possession of the unit may be immediately obtained by the landlord. Thus, the longer the wait time for a case to be resolved, the higher the financial strain and risk of homelessness for the tenant, and the greater the business impact for the landlord. The Eviction Appeal Support program utilizes the ARPA funds to hire a dedicated Associate Judge and a Court Coordinator who will focus on the reduction of the eviction appeal cases backlog and the time to disposition.

Multi-Family Development

The Multi-family Development Program was designed to use Treasury ARPA funding to create and preserve the number of affordable rental units in Harris County. Funds are provided for the acquisition, rehabilitation, reconstruction, and new construction of affordable multifamily housing projects in Harris County. Harris County Community Services Department will partner with the Harris County Housing Finance Corporation and third-party real estate broker and hire staff to carry out the program.

For each of these developments, Harris County will impose new deed restrictions that extend the tenant income restrictions, rent limits, and period of affordability for at least 20 years for properties acquired. The affordable rental units created or preserved by the program will be restricted to low-to moderate-income (LMI) residents. The program will increase the affordable housing stock in Harris County and provide more options for renters.

Homelessness

Community COVID Housing Program (CCHP)

The Community COVID Housing Program (CCHP) was designed with the goal of scaling permanent and long-lasting approaches and interventions that have demonstrated success in reducing homeless populations. It also aims to reduce the amount of time that an individual experiences homelessness, increase permanent housing options, and decrease encampments. CCHP provides a strategy that not only responds to the crisis of the pandemic but also strategically utilizes federal funding to reduce homelessness and further save lives.

HAY Center

The HAY Center Campus will serve homeless youth and young adults who have aged out of the foster care system and are at or below 50% area median income (AMI). The campus will feature a 17,000-sq-ft wraparound services building with offices, meeting rooms, a computer lab, and life skills training rooms, as well as a 41,000-sq-ft residential building with 50 apartments, community space, a kitchen, a small gym, a business center, and private study rooms.

Infrastructure

Water and Sewer Infrastructure

The ARPA Wastewater Infrastructure project aims to increase access to functional sewer systems, particularly in vulnerable communities where minimizing environmental and public health impacts of septic system failure is critical. Insufficient access to reliable sewage infrastructure compromises general health and contributes to the spreading of contagious diseases, and decentralized systems in low-income areas have higher rates of failure, leading to polluted and compromised water sources.

Community Facility & Infrastructure Investments: Infrastructure

The Community Facilities & Infrastructure Investments program seeks to utilize ARPA funding for community facilities, infrastructure investments, and public services to increase the operational capacity of nonprofit organizations and local government programs. Investments will prioritize improving the lives of county residents through:

- Reducing the number of residents experiencing homelessness, housing insecurity, or food insecurity
- Expanding access to behavioral health supports
- Expanding access to healthcare
- Reducing violent crime and domestic violence or sexual abuse.

The following types of projects will be selected that expand the scope and equitable impact of non-profit organizations and local governments:

- Renovation or construction of new physical infrastructure with a focus on augmenting the capacity of nonprofit organizations
- Strategic acquisition of pre-existing facilities to increase the operational capabilities of non-profit organizations
- Construction projects needing gap financing that are slated for completion within the stipulated ARPA expenditure deadlines

- Capital improvement projects designed to support nonprofit organizations dedicated to addressing food insecurity, homelessness, behavioral health, and/or violence or domestic violence reduction
- Existing programs that need an increase in operational capacity including but not limited to providing for increased staffing needs, in alignment that addresses barriers to the improvement or stabilization of the lives of county residents' such as food insecurity, housing insecurity and homelessness, domestic violence or sexual abuse, mental health, and behavioral health support

Funding will be distributed equally for projects across the four Harris County Precincts.

Early Childhood Initiatives

Child Care Subsidy Process Improvement

Enabled by the FLEX Fund, child care subsidy process improvement exploration has incorporated several input mechanisms, including surveys and focus groups for parents, interviews with stakeholder organizations, accessibility analysis by a community-based organization, interviews with staff engaged in processing child care subsidy applications, and more.

Across jurisdictions, Harris County is making some of the most substantial American Rescue Plan investments in early childhood and child care. The Early Childhood team will ensure that those efforts are informed by community input and results are shared broadly.

Child Care Workforce Supports

A thriving child-care workforce is a critical component to ensuring Harris County residents have better access to high-quality child care. Due to low pay, difficult working conditions, and limited free time, child-care workers are often unable to access high-quality training and education to support their career development and progression in the industry. Through this RFP, Harris County seeks to attract new workers into the sector, retain the existing workforce, and support members of the workforce in their career and wage growth. Harris County Accessible Child Care Training Supports (ACCTS) will invest directly in the Harris County child-care workforce to provide highly incentivized training and education opportunities.

County Connections

County Connections Youth Summer Initiative will provide grants to organizations that offer comprehensive summer programming, short-term projects, and other enrichment for children ages 5-18 through The Harris County Department of Education (HCDE) Center for Afterschool Summer and Enrichment (CASE) for Kids. County Connections fills gaps in existing enrichment services for youth, sponsors full and partial scholarships to assist families with program fees, and includes college and career readiness initiatives for older children. During the pandemic, grantees provided direct service activities, virtual learning activities, or hybrid lessons. This program aims to ensure accessibility and meet the health and safety guidelines related to COVID-19 to provide children with enriching activities they did not have during the pandemic.

Early Childhood Impact Fund

Harris County's Early Childhood Initiatives department recognizes the necessity of investing in early childhood development and will expand access to affordable, dependable, high-quality child care.

- The Texas Children's Hospital upWORDS community-based training supports infant and toddler brain and language development.
- The Safe Babies program from First3Years works with families and children within the child welfare system to minimize the harm of family separation and prior maltreatment.
- The Alliance's Home-based Childcare support program will provide training to home-based childcare providers, including helping unlicensed programs gain certification and increasing the quality of programming, care, and business operations.

- Kids' Meals was chosen to expand the healthy meal delivery program to children and families in Harris County. The purpose of Kids' Meals is to provide children relief from severe food insecurity and food deserts in poverty-stricken neighborhoods.
- The Rupani Foundation uses community-driven approaches to provide holistic, culturally relevant, and respectful support programs for resource-limited families parenting or expecting infants and toddlers

Early Childhood Initiatives Admin

Harris County's Early Childhood Initiatives department recognizes the necessity of investing in early childhood development and will expand access to affordable, dependable, high-quality child care. This funding will allow the County to hire an Associate Director and Analyst to support Early Childhood Initiatives throughout the County. The Associate Director is responsible for providing senior leadership to the County's early childhood work and will lead the management of internal County processes and procedures to ensure the success of the portfolio. The Analyst will develop reports, track partner and portfolio progress, and analyze data to understand the effectiveness of the early childhood portfolio.

Early Learning Quality Networks

The Quality Network Support Hub will provide planned, and on-call supports for each Local Support Organization to accomplish its goals. These supports can include but are not limited to training and coaching on baseline definitions of quality, materials, and support to create community plans, and access to experts in various aspects of the early childhood field. The Local Network Organizations will be housed at a community-based organization within a target community across Harris County. They will form an Advisory Group to guide their work which will consist of child-care providers, families, education and health professionals, and other key stakeholders that represent that community. The Local Network Organization will hold community conversations to adopt a definition of quality for their community and identify key initiatives to support childcare while building relationships. They will fund and oversee quality initiatives across all types of child care including center-based, home-based, and family and friends child care.

Early REACH

Early REACH (Raising Educational Access for Children in Harris County) programming works with high- quality child care centers to add 800-1,000 new child care slots that are in, or near, child care deserts and have a high social vulnerability index. This is a pilot program using a contracted slots model to increase providers' capacity to provide high-quality child care. The focus is on children with the least access to care: infants, toddlers, and 3-year-olds, families with low incomes, and families in high-poverty areas. Additionally, Early REACH will assist the staffing of child-care environments by requiring a living wage for classroom staff and supporting good working conditions to reduce teacher turnover. Early REACH also creates strong, durable small businesses by building entrepreneurial practices to support the sustainability of child care.

Helping Hands

Helping Hands aims to provide funding and support to community-based organizations in improving and increasing efforts to contact and inform likely eligible residents and enroll them in public benefits programs. The targeted public benefits programs for Helping Hands include Children's Medicaid, CHIP, CHIP for pregnant women, SNAP, and the Harris Health Financial Assistance Program. The program aims to enroll at least 1,000 residents in public benefits programs and build sustainable benefits enrollment capacity and knowledge among Harris County community-based organizations. The Alliance of Community Assistance Ministries (ACAM), the intermediary organization will conduct a granting program to subrecipients to achieve the goal of Harris County Helping Hands.

Inspire

Inspire provides grants to qualifying families to promote community inclusion, prevent institutionalization, and improve developmental outcomes for young children. Inspire participants can receive up to \$5,000 in financial assistance for assistive technology, learning materials, and/or services directly related to the disability, plus \$1,000 for respite care (approximately 100 hours). It is estimated that 250 Harris County residents will receive a grant each year (500 unduplicated within the 24-month contract term). The Harris Center for Mental Health and IDD has been awarded the contract to administer the two-year program.

RAPID-EC Survey - FLEX

To ensure accurate information about families with children under age 5 who need access to child care programs, a partnership with the University of Houston to administer Stanford University's RAPID Survey for Early Childhood (The Rapid Assessment of Pandemic Impact on Development). The survey, which will be conducted over two years, collects vital information about:

- Families' needs in relation to child care and healthcare
- Families' needs in relation to impacts of COVID-19
- Mental health and wellbeing of parents and children
- Material hardships for families before and during the COVID-19 pandemic

This information will provide us with real-time information about families most in need of child care. Our goal is to reach 1,500 families with the survey; all results will be shared openly with the public. Outreach through a broad group of partners will maximize reach.

Resiliency Fund

The Early Childhood Resiliency Fund will help reduce the harmful developmental impacts of early exposure to violence by investing in trauma-informed programs and strategies for young children exposed to domestic violence (DV) and intimate partner violence (IPV). Eligible families are families with young children that have been exposed to DV/IPV. The purpose of this program is to improve developmental outcomes for the eligible population. Progress towards the goal will be measured through various diagnostic batteries. The Harris County Domestic Violence Coordinating Council will provide grants to local nonprofit organizations to provide for developmental and therapeutic interventions for the intended beneficiaries.

RISE

Responsive Intervention Services & Engagement (RISE) will improve the continuum of care for young children with disabilities in Harris County. Three strategies will be deployed through RISE:

- Dedicated resource specialists: Harris County residents will have access to a 24.7 resource helpline to advise families of children with disabilities on resources and navigating the service landscape. There are no specific eligibility requirements for this service. Service target is 1200 callers a month.
- Enhanced Early Intervention Services: Certified family partners will be incorporated into the program to support family navigation and retention in the services. Eligibility criteria for ECI will also be expanded. Eligible families include families of children up to age 3 with qualifying developmental delays or medical diagnoses. Service target is 160 children through ECI, and 500 families through CFP.
- Applied Behavior Analysis Skills Intervention Program (ABA-SKIP): The intervention is designed for children ages 3-8 years old with autism displaying inappropriate classroom behaviors and developmental delays. Eligible families include those with children ages 3-8 with autism spectrum disorders and other developmental delays. Service target is 100 children.

Shine Facilities

The SHINE Childhood Facilities Fund is Harris County's first-ever facilities-specific funding for providers in the region to receive support for construction, remodeling, and expansion projects for the physical spaces in which they offer early learning and care. The SHINE Fund serves to increase providers/ access to capital and resources to make safe and nurturing environments for Harris County's children. It also serves as a model to further examine the efficacy of offering providers access to funding pre-determined for altering their facilities, and in turn, its effects on children's learning and growth.

Family Financial Stability

Direct Assistance

In 2021, Harris County and Catholic Charities partnered to administer a total of \$60 million in financial assistance to Harris County residents. The allocated funds were part of a larger portion of federal funds received by Harris County through the American Rescue Plan Act (ARPA,) in response to the financial distress caused by the COVID-19 pandemic. The program provided a one-time cash transfer of \$1,500 to households located within Harris County that met eligibility requirements such as having at least one household member enrolled in a public assistance program, or a total household income at or below 60% of the United States Department of Housing and Urban Development (HUD) Area Median Family Income. Recipients were allowed to use the payment for any COVID-related emergency expenses such as healthcare, rent or mortgage, utilities, food, internet, transportation, childcare, and other past-due expenses.

Immigration Legal & Naturalization Services

The Immigration & Naturalization Legal Services Fund will provide legal representation to indigent detained immigrants and immigrant families facing removal.

Tax Credit Assistance

BakerRipley Neighborhood Tax Centers (NTC) provide free, quality tax preparation for low-income families and individuals who earn up to \$58,000. The Volunteer Income Tax Assistance (VITA) program also assists taxpayers in claiming the Child Tax Credit (CTC) and the Earned Income Tax Credit (EITC) for which they are eligible. Funding from Harris County supports nine in-season Tax Center locations and 16 mobile sites within the County. The funding also supports three-year-round tax center locations open from May through November.

Uplift Guaranteed Income Pilot

The Uplift Guaranteed Income Pilot is an 18-month pilot that will provide continuous cash transfers to eligible low-income individuals and households to ensure an income floor and address economic inequality for low-income households most affected by the pandemic. Each participating household will receive \$500 per month. The pilot includes funding for two cohorts. The first cohort includes randomly selected persons who reside within the top ten high-poverty zip codes where the COVID-19 pandemic and corresponding economic crises have adversely impacted residents. The second cohort includes priority populations under ACCESS, a coordinated and client-centered safety net service delivery model administered by Harris County Public Health. Funds available for ACCESS participants are intended to maximize the impact of targeted services offered to participants by Harris County agencies.

Small Business

Disparity Study Fund - FLEX

The Disparity Study Fund supports eligible entities in Harris County in developing inclusive procurement practices through the completion of a disparity study. Studies will be commissioned by both Community Colleges and Independent School Districts on the condition that participating entities will develop and implement model MWBE programs using national best practices.

Harris Hub Small Business Assistance

Harris Hub will provide funding to Business Support Organizations (BSOs) to increase their capacity to provide in-depth and culturally competent technical assistance to small and micro businesses affected by the pandemic, with a focus on Minority- or Women-owned Business Enterprises (M/WBE) and business owners in Qualified Census Tracts (QCTs) as designated by the U.S. Department of Housing and Urban Development (HUD).

Jobs Portfolio Admin

The Department of Economic Equity and Opportunity (DEEO) activates resources, partners, direct assistance, and data to eliminate economic disparities and disinvestments in Harris County. This Workforce Administration funding will allow DEEO to hire an Assistant Director of ARPA Initiatives, who will be responsible for overall implementation, compliance, reporting, and close-out of programs funded by ARPA. Responsibilities include program evaluation and reporting, portfolio management, managing staff responsible for DEEO ARPA programs, communicating project progress to various stakeholders, and developing and managing relationships.

Revolving Loan Fund

The Revolving Loan Fund provides small businesses equitable lending with competitive rates and flexible terms microloans up to \$50,000 and growth loans up to \$250,000 with the goal of addressing disparate access to capital.

Workforce Development

Apprenticeship Advantage

The Apprenticeship Advantage program aims to expand and create opportunities in traditional and high- growth emerging industries within Harris County while offering individual coaching and a pipeline to open employment opportunities. It also seeks to provide wraparound support and financial resources to residents experiencing un- and under-employment for successful completion of programs and transition to work.

Hire Up Harris

Hire Up Harris supports comprehensive approaches to workforce development characterized by training complemented by soft skills development, professional skills development, and wraparound services. The goals of this program include the promotion of skills training and wraparound support services that can lift target populations—underemployed, unemployed, dislocated workers, opportunity youth, people of color, women, and those without college degrees—from poverty and economic insecurity.

Harris County also seeks to build capacity among organizations that provide workforce training. Importantly, this program aims to support programming that includes wraparound support services that increase apprenticeship program completion, placement rates, and retention rates.

COUNTY OPERATIONS

County Ops

ARPA Administration

The ARPA Portfolio Management Office (PMO) ensures the 80+ programs in the Harris County ARPA portfolio deliver target outcomes and fully comply with US Treasury regulations.

Data Fellows

The Harris County Office of Performance and Data and the Office for Human Resources and Risk Management are launching the Harris County Data Fellows Program to empower County government agencies to improve their services to citizens through data-driven decision-making. Talented data analysts collaborate with County leaders to tackle key data challenges through operational guidance, performance tracking, county-wide support, and automation. Data Fellows seek data-driven performance in County government and are dedicated to improving services rendered to the citizens of Harris County.

General Fund Support

The Harris County Office of County Administration (OCA) was directed by Commissioners Court to develop a project for \$19,500,000 in revenue replacement during the FY 2024 budget cycle. Due to significant losses in revenue during the COVID-19 Pandemic, a budget shortfall has been projected for FY2024.

Position Standardization & Pay Equity

The Harris County Office for Human Resources and Risk Management (HRRM) is launching the Harris County Position Standardization and Pay Equity Program to address disparities in compensation. The market-based salary structure is the most common type and involves basing employees' salary structure on what other companies in the same industry and geographical location offer in their compensation packages. The current recommendation is to decrease the total number of pay grades from 79 to 30 and centralize the pay structure throughout county departments.

Voter Outreach and Education

Harris County voters have faced increased voting access challenges due to COVID-19 risk and changes to the Texas Elections Code. Commissioners Court approved ARPA funding for voter education and outreach services related to elections in 2022, 2023, and 2024 for branding, marketing, and strategic communication services. The purpose of this program is to execute a paid media campaign focused on educating voters in Harris County about election basics, including how to operate new voting machines, and to increase understanding of the new processes for in-person and/or vote-by-mail.

FLEX Fund

FLEX Expenses

The FLEX Fund was created to allow for faster delivery of priority outcomes by reducing the compliance burden of programs and allowing the use of locally procured vendors. It is funded from a budget made available by transferring eligible expenses to the ARPA fund and freeing up the general fund budget.

JUSTICE & SAFETY PORTFOLIO

Justice & Safety

Court Backlog

Addressing the criminal case backlog generated by pauses during the pandemic is key to ensuring speedy access to trial for defendants and victims. ARPA funding is dedicated to increasing the speed and efficiency of these operations. Funds were allocated to accelerate evidence processing and provide additional court space, judges, jury services, court staff, and attorneys to mitigate impacts of the pandemic-related court backlog. Funding supports the development of a pretrial analytics database and a program to quickly bring one-time, low-level offenses to disposition. Additionally, ARPA funding is helping to improve forensic science staff retention efforts and support elevated pathology and decedent transport needs. Further, funds support the Children's Assessment Center in addressing child abuse through a digital conversion project, upgraded technology, single-session therapy, new staff, and training sessions. Both defendants and survivors of crimes have been negatively impacted by having cases remain unheard for long periods of time.

Overall, the key outcome goals are reducing exposure to the criminal justice system and increasing the speed of access to a hearing or trial. Impacts of funding are measured in terms of the decrease in number of court cases in the backlog, improvements in the average time to case disposition, number of backlog cases disposed, clearance rates, contribution to backlog cases by emergency response dockets, associate judge dockets, and case management analysts. Progress in staff hiring and retention is also being tracked.

Detention Officers

The ARPA-funded Detention Officer Retention Incentive Program will provide incentive payments to Detention Officers in the Harris County Sheriff's Office (HCSO) with the goal of improving staff retention. The HCSO is committed to ensuring public safety, including the safety of HCSO employees and the justice-involved persons entrusted to their care in the County Jail system. While HCSO maintains the largest jail in Texas and continues to

grow its department, employee turnover continues to be high. Turnover of Detention Officers is costly to the department because it is labor and cost-intensive to find and train new employees. Additionally, when turnover rates are high, the number of staff available to perform supervisory duties decreases. Currently, 67% of Detention Officer resignations occur within the initial two years of employment. By providing ARPA-funded incentives for Detention Officers during this important period, the HCSO is targeting increased employee retention. Incentivizing Detention Officer staff may additionally contribute to improved safety conditions for Harris County Jail inmates and staff by ensuring adequate jail staffing.

Jail Population

The Harris County Jail population grew during the COVID-19 pandemic. A few factors contributing to the increase in jail population included the growth of the court backlog (already high following Hurricane Harvey impacts), a spike in violent crime during the pandemic, and state legislative changes. In order to remain at recommended capacity levels, the Harris County Sheriff's Office determined a need for outsourced jail capacity. Commissioners Court allocated \$25.7 million to relocate Harris County Jail inmates to the Giles Dalby Correctional Facility in Post, Texas via a contract with Management & Training Corporation (MTC). The facility provides medical and dental services to inmates, as well as recreational spaces and transport to court as needed. The goals of this program are to provide a safer environment for both inmates and Harris County Sheriff's Office personnel and to meet state jail regulations.

Jail-based Competency Restoration

The Jail-Based Competency Restoration (JBCR) program, operated by the Harris Center for Mental Health and Intellectual Disabilities, provides mental health treatment to these inmates and combines individual and group therapy, co-occurring substance abuse services, trauma-informed care, peer support services, medication management and nursing services with a focus on individualized care, and factual and rational court education services, and has been tremendously successful. During FY 2022, the program had a competency restoration rate of 93%—more than double the average rate for other JBCR programs in Texas (40%)—and its average length of stay, 55 days, is a fraction of the wait time for a state hospital bed.

TeleDeputy

ARPA funds support the Harris County Sheriff's Office (HCSO) for the TeleDeputy Unit to allow deputies to work overtime at the Emergency Dispatch Center (EDC) to respond to 911 calls for services that do not require an onscene law enforcement response. The TeleDeputy Unit staffing plan allows up to 126 shifts per week and 504 workforce hours, and all Priority 3 and 4 calls for service that are eligible for TeleDeputy will be routed to the unit. During 2022, HCSO responded to 410,862 dispatched calls for service, with close to 60% of these calls being Priority 3 and 4, which generally do not require an on-scene law enforcement response. Managing these lower-priority 911 calls remotely will allow patrol deputies to provide a faster response time to higher-priority 1 and 2 calls requiring an on-scene patrol investigation and should decrease response times to all priority levels of 911 calls.

Violent Persons Warrants Task Force

During the COVID-19 pandemic, Harris County experienced a rise in violent crime, resulting in an increase in warrants issued and an accumulation of outstanding warrants. The Harris County Violent Persons Warrants Task

Force is a multi-agency task force led by the Harris County Sheriff's Office in collaboration with Harris County Constables that seeks to address the backlog in outstanding warrants and reduce extradition costs through accelerated execution of warrants related to the most violent offenses. Outstanding warrants for offenders accused of aggravated offenses and murder are prioritized. American Rescue Plan funding for the program supports personnel costs and equipment required for the Task Force.

Violence Prevention

Domestic Violence Assistance Fund

The Domestic Violence Assistance Fund will provide flexible financial assistance to survivors of domestic violence via grants to not-for-profit community-based organizations that serve this population. Flexible funding for domestic violence survivors has been described by both survivors and service providers as "lifesaving." Survivors can use flexible funding to cover basic needs to successfully leave abusive situations and seek stability by covering costs for housing, transportation, childcare, utilities, and other needs. Recipient organizations may also use a limited portion of the funds to build organizational capacity to address unmet needs of survivors.

Youth Diversion

The Youth Diversion Center, operated by the Harris Center for Mental Health and Intellectual and Developmental Disabilities, serves as an alternative to juvenile detention for Harris County youths ages 13-17, who have committed low-level, non-violent offenses and temporarily need respite care due to a behavioral health crisis. Offenses qualifying for diversion are determined by the Harris County Juvenile Probation Department and the District Attorney's Office. The Youth Diversion Center provides clients with comprehensive rehabilitation services in a safe, supportive environment with crisis intervention, family counseling, and reintegration services included during their stay.

Re-Entry/ Reintegration

Women's Empowerment Center

The Women's Empowerment Center's (WEC) core mission is to address the needs of women housed in the jail facility and successfully prepare them for transition out of the criminal justice system through connection to services during and after incarceration. The WEC provides women in custody with intensive, individualized case management and productively engages them in a robust series of programming opportunities and wraparound services designed to meet their unique needs. ACCESS Harris provides early intervention intensive programming and case management for the women in the facility and works in partnership with the HCSO staff to ensure the successful execution of re-entry support and services. The supportive services offered by HCSO and ACCESS Harris aim to provide a holistic approach to coordinated care to meet the needs of the female jail population.

COMPLETED PROJECTS

HEALTH PORTFOLIO

Behavioral Health: Healthy Minds, Healthy Communities

Healthy Minds, Healthy Communities (HMHC) is a Community Initiated Care (CIC) program with the goal of strengthening community behavioral health and resiliency. The program identified 10 key neighborhoods, which are largely communities of color disproportionately impacted by COVID-19, with high rates of poverty, increases in suicide, and barriers to behavioral health services. The program identifies community touchpoints and conducts outreach to raise awareness of mental health and treatment options, offers community-based trainings, and establishes support groups for survivors of suicide loss. The purpose of these tools and trainings is for community members to be able to support each other in times of emotional need. Program completed on 10/25/2024 and hosted 298 trainings and events.

Emergency Nursing

Over 602 nurses, respiratory therapists, and other medical staff were temporarily placed with 18 area hospitals in response to the Delta surge, with an additional 361 placed during the Omicron surge, substantially alleviating staffing shortages and providing critical support to patients. Harris County received a \$47 million reimbursement from FEMA for this program.

Vaccine Incentives

The countywide vaccine incentive offer ended at the end of September 2021, after incentivizing more than 30,000 incremental vaccinations above baseline forecasts.

Food & Nutrition: Urban Harvest

The ARPA Food & Nutrition Program aims to address food insecurity in Harris County by increasing access to healthy foods and strengthening our local food and nutrition infrastructure. This program is improving food distribution infrastructure, providing food and nutrition services to individuals disproportionately impacted by the pandemic or living in food deserts, and providing small capacity-building grants to hyperlocal food providers. **Urban Harvest** managed and hosted recurring mobile or pop-up markets and provided nutrition education. Program completed on 5/31/2024.

Behavioral Health Counseling for Youth and Families: Covenant House Texas

The ARPA Behavioral Health Counseling for Youth and Families Program was created to increase access to behavioral healthcare services within schools and/or neighborhoods located in socially vulnerable areas within Harris County. The program aims to increase the capacity of community-based organizations and non-profits in the identification and treatment of behavioral health needs in school-aged youths and their families. **Covenant House Texas** provided mental health services to 193 youths. Program completed on 11/14/24.

HOUSING PORTFOLIO

Employ2Empower (E2E)

Employ2Empower (E2E) is a county-wide, employment-first model that connects participants with a viable path to a healthy, productive, and economically stable future. The E2E program helps the unhoused and those living in encampments to reenter the workforce and utilize wrap-around services. The program aims to provide a low barrier for participants to gain employment, along with access to social services, such as housing navigation, healthcare, and income support, with the goal of connecting participants to a pathway to permanent housing solutions.

JOBS & EDUCATION PORTFOLIO

Flexible Financial Assistance

The Harris County Recovery Assistance program administered by Catholic Charities has completed the distribution of funds, with \$60 million in assistance provided to 40,000 families.

Small Business Relief

Harris County created the \$30 Million Harris County Business Relief Fund to accelerate recovery for microenterprises and small businesses impacted by the COVID-19 pandemic. The Fund provided grants ranging from \$5,000 to \$25,000 to eligible microenterprises and small businesses located inside Harris County. LiftFund, a Texas Community Development Financial Institution (CDFI) with over 25 years of experience serving small and underserved entrepreneurs, administered the program and coordinated outreach through 90 community partners and five navigator agencies.

JUSTICE & SAFETY PORTFOLIO

Gun Buybacks

Harris County and similar-sized counties across the nation have recently experienced an uptick in gunrelated violence and deaths. Voluntary gun buyback programs allow gun owners to surrender personal firearms to governmental law enforcement entities in exchange for a gift card. The primary goal of the program is to remove unwanted firearms from the community, thus reducing the potential for these guns to cycle through illegal networks or become potential hazards in the home. The Gun Buyback program promotes a reduction in gun violence and prevention of crime by removing illegal or unwanted firearms from the street. The program held three events in 2023 and collected 2,700 firearms.

ACTIVE PROJECTS - OTHER FUNDING SOURCES

HOUSING PORTFOLIO

Rental Assistance via ERA 1 (complete) and ERA 2 (ongoing)

Harris County's rental assistance program helps vulnerable families remain housed while also supporting landlords with struggling tenants. The Houston-Harris County Emergency Rental Assistance (ERA) Program has been nationally recognized for its effectiveness of fund distribution, accessibility, and outreach.

Key Updates

- Commissioners Court approved an additional allocation of \$3.2M of ERA 2 funds to Catholic Charities to assist eligible renter households impacted by the COVID-19 pandemic
- The ERA program is now focused on tenants with an active eviction case
- Harris County has received \$172.1M of ERA Funds to-date
- \$322 million in assistance has been disbursed to date via over 77,000 awards through the combined Harris County and City of Houston ERA program
- The average spending per month in the current fiscal year has been \$225,000
