Funded by the U.S. Department of Homeland Security via the Office of the Governor, Homeland Security Grants Division, the Homeland Security Grant Program is comprised of three interconnected grant programs: the State Homeland Security Program (SHSP), the Urban Areas Security Initiative (UASI), and Operation Stonegarden. The State Homeland Security Program supports state, tribal, and local preparedness activities that address high-priority preparedness gaps across all core capabilities where a nexus to terrorism exists. Per Congressional mandate, 25% of Homeland Security Grant Program funding must be spent on Law Enforcement Terrorism Prevention Activities (LETPA).
