The County Judge thereupon announced that the motion had duly and lawfully carried and that the order had been duly and law-fully adopted. The order thus adopted follows:

Recitals:

1. Harris County, acting by and through its Human Resources & Risk Management Department, entered into an agreement (the “Contract”) with McGriff Insurance Services, Inc. to provide all risk property insurance and business coverage for Jesse H. Jones Memorial Bridge. McGriff Insurance Services, Inc. now desires to assign the remainder of the Contract to McGriff, a Marsh & McLennan Agency LLC Company.
2. McGriff, a Marsh & McLennan Agency LLC Company, is a separate company from McGriff Insurance Services, Inc. as evidenced by the Merger Certificate dated November 15, 2024 and the W-9 Form dated December 6, 2024.
3. The assignment shall begin upon approval by Commissioners Court and remain in effect until completion of the services.
4. Harris County now desires to change the managing department to the Harris County Office of Management & Budget.

IT IS ORDERED that:

1. The recitals set forth in this Order are true and correct.
2. The Harris County Commissioners Court authorizes the assignment of the rights, duties and privileges under the Contract from McGriff Insurance Services, Inc. to McGriff, a Marsh & McLennan Agency LLC Company.
