It is understood and agreed that any acceptance of the dedication of any roads served by

the storm sewer system shall not be construed as acceptance of the storm sewer system or any part thereof into the County's road system except to the extent such acceptance is expressly stated. While the County expressly disclaims any acceptance of the storm sewer system into the

County storm sewer system, the County shall retain the right but not assume the obligation to make any and all necessary emergency repairs or perform maintenance of the storm sewer system. The District's acceptance of the storm sewer system includes such items as trunklines, leads and inlets, but does not include any "amenity" feature of a system. The District agrees that in maintenance or repair of the storm sewer system, it shall not 5. allow any damage of public street paving, and that all actions within the road right-of-way shall be in accordance with applicable Harris County rules, regulations and requirements. The County agrees to reevaluate acceptance of the drainage system into the County 6. maintenance system on the 11th day of November , 2028. This instrument contains the entire agreement between the parties relating to the responsibilities and requirements of the maintenance of the storm sewer systems within the Westhaven Manor Section 1 (Name of Subdivision and Section(s), if applicable) development. Any modifications concerning this instrument shall be of no force and effect accepting a subsequent modification in writing, approved by the governing bodies and signed by all parties hereto.
