The County Judge thereupon announced that the motion had duly and lawfully carried and that the order had been duly and lawfully adopted. The order thus adopted follows:

Recitals:

1. Harris County entered into an agreement (the "Contract") with Bushive, LLC. to provide transportation software services for Harris County Precinct 4. Bushive, LLC. now desires to assign the remainder of the Contract to Transit Workforce Management, LLC.
2. Transit Workforce Management is the new name for Bushhive, LLC. as evidenced by the Certificate of Merger and Amendment between Bushhive, LLC. and Transit Workforce Management, LLC. attached hereto as Exhibit A.
3. The assignment shall begin upon approval by Commissioners Court and remain in effect until completion of the services.

IT IS ORDERED that:

1. The recitals set forth in this Order are true and correct.
2. The Harris County Commissioners Court authorizes the assignment of the rights, duties and privileges under the Contract from Bushive, LLC. to Transit Workforce Management, LLC.

4. All Harris County officials and employees are authorized to do any and all things necessary or convenient to accomplish the purpose of this Order.
