WHEREAS, pursuant to Chapter 343 of the Texas Health And Safety Code (formerly Vernon's Texas Civil Statutes Article 4477-9b), and the Harris County Nuisance Abatement Procedures adopted by the Commissioners' Court on June 3, 2008, Harris County, acting through the Director of the Harris County Public Health Services, (said Director being the regularly salaried, full-time county employee designated by the Harris County Commissioners' Court to administer the Harris County abatement Procedures) did give a Notice to Abate Public Nuisance to the owner(s) of the premises located at the below listed addresses, stating the specific condition on the said real property that constitutes a public nuisance; and

WHEREAS, said notice(s) did comply in all respects with the requirements as stated in said Code and the Harris County Nuisance Abatement Procedures; and

WHEREAS, the said public nuisance at each property was not eliminated within the time prescribed by the Harris County Nuisance Abatement Procedures; and
