AMENDMENT ONE

TO FLEX SERVICES AGREEMENT AND ADDENDUM TO THE AGREEMENT

This Amendment One (“Amendment One”) to the ShotSpotter® Flex™ Services (now ShotSpotter® Respond™) Agreement and the Addendum to the Agreement (collectively the “Agreement”) dated December 17, 2020, entered into by and between Harris County (“County”) and ShotSpotter, Inc. (“Contractor”) is effective as of the last date of signature below. County and Contractor may also be referred to herein individually as a “Party”, or collectively as the “Parties”.

The Parties agree as follows:

1. The Coverage Area for the County’s implementation for the ShotSpotter Respond services as set forth ShotSpotter’s Proposal #HARCOTX111020 attached to and incorporated in the Agreement, is 4.0 square miles.
2. Subsequent to the execution date of the Agreement, the Parties have mutually determined that an adjustment to the Coverage Area as shown in Exhibit A attached hereto, would enhance the ShotSpotter Respond services for the County.
3. The net change in the Coverage Area is an additional 0.48 square miles.
4. ShotSpotter agrees to waive all service initiation fees to adjust the Coverage Area; and agrees to waive the subscription fee for the additional 0.48 square miles for the term of the Agreement.

Except as amended herein, all other terms and conditions of the Agreement shall remain in full force and effect. In the event of a conflict between the terms and conditions of the Agreement and this Amendment One, the terms and conditions of this Amendment One shall control.


This Amendment One may be executed in multiple counterparts. Each counterpart is deemed an original, and all counterparts together constitute one and the same instrument.



