The County Judge thereupon announced that the motion had duly and lawfully carried and that the order had been duly and law-fully adopted. The order thus adopted follows:

### **Recitals:**

1. On September 19, 2024, Harris County entered into an agreement (the "Agreement") with Locke Lord LLP to obtain Locke Lord LLP, through Crystal Brown, as a liaison for Harris County with the members of the legislature, legislative committees, state agencies, and state officials in Austin, Texas. Locke Lord LLP now desires to assign the remainder of the Agreement to Troutman Pepper Locke LLP.

2. Locke Lord LLP merged with Troutman Pepper Hamilton Sanders LLP on January 1, 2025, becoming Troutman Pepper Locke LLP as evidenced by the Amended and Restated Limited Liability Partnership Election of Troutman Pepper Locke LLP.

3. The assignment shall begin upon approval by Commissioners Court and remain in effect until completion of the services.

# **IT IS ORDERED** that:

1. The recitals set forth in this Order are true and correct.

2. The Harris County Commissioners Court authorizes the assignment of the rights, duties and privileges under the Agreement from Locke Lord LLP to Troutman Pepper Locke LLP.
