The objectives of the Title IV-B and Title IV-E programs are to establish, extend, and strengthen child welfare services provided by state and local, and Indian Tribal public welfare agencies that enable children to remain in their own homes, or, where that is impossible, that provide alternate permanent homes for them; and to help states provide safe, appropriate, 24-hour, substitute care for children who are under the jurisdiction of the administering state agency and need temporary placement and care outside their homes. The Consolidated Appropriations Act, 2021 (H.R. 133) includes \$900 billion in stimulus relief for the COVID-19 pandemic in the United States.

 BILATERAL CONTRACT AMENDMENT**

This Bilateral Amendment No. 05 (Bilateral Amendment) modifies Contract # HHS000669100001 (Contract) and is entered into by the Texas Department of Family and Protective Services (DFPS) and Harris County for Claims Processing services.

I. PURPOSE.

As provided for in Section V of the DFPS Interagency and Interlocal Uniform Terms and Conditions, which is incorporated as part of this Contract, the Contract is being modified to increase the budget and add new service code to comply with Section 427(a)(1) of the Social Security Act, the KIN NAV Grant for Title- IV E agencies.

II. CONTRACT MODIFICATIONS.

A. The Parties agree to amend Section IV of this Contract to increase the budget by **\$81,283.00** for the sole purpose of providing Kinship Support Services.

B. The Parties agree to delete 2.8.1.1. in its entirety and replace with the following:

2.8.1.1. Information needed to authorize the disbursement
