

**SECOND AMENDMENT TO THE AGREEMENT BETWEEN HARRIS COUNTY AND
BUTLER SNOW LLP**

This Second Amendment to the Agreement is made and entered into by and between Harris County (the "County"), a body corporate and politic under the laws of the State of Texas and Butler Snow LLP ("Counsel"). County and Counsel are known individually as "Party" and collectively as "Parties."

Recitals

On or about December 21, 2022, the County entered into an agreement with Counsel to provide representation and advice regarding *La Union Del Pueblo Entero, et al., v. Gregory W. Abbott et al.*; Civil Action No. 5:21-cv-844 (consolidated cases), in the United States District Court for the Western District of Texas, and other related matters (the "Master Agreement").

On October 8, 2024, the Parties amended the Master Agreement for the first time (the "First Amendment") to increase funding and to correct the Recitals.

The County and Counsel now desire to amend the Master Agreement for the second time (the "Second Amendment") for the purpose of incorporating a Rate Schedule into the Master Agreement.

Counsel warrants and represents that it is willing and capable of providing the services.

Terms

1. CONTRACT CONSTRUCTION

This Second Amendment shall be governed by the Master Agreement and the First Amendment, which are incorporated by reference as though fully set forth word for word.

2. RATE SCHEDULE

The Rate Schedule referenced in the Section J of the Master Agreement, but not attached to the Master Agreement as Exhibit B or incorporated into the First Amendment, is hereby incorporated into the Master Agreement to include the following:

3. ORDER OF PRECEDENCE


In the event of any conflict between the terms and provisions of this Second Amendment, or any portion thereof, and the terms and provisions of any other part or portion of the Master Agreement or the First Amendment, this Second Amendment shall control.

All other terms and provisions of the Master Agreement shall remain in full force and effect as originally written and subsequently amended.


4. EXECUTION, MULTIPLE COUNTERPARTS


