FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN HARRIS COUNTY AND THE UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER AT HOUSTON

THE STATE OF TEXAS §

COUNTY OF HARRIS §

This First Amendment to the Agreement is made and entered into by and between Harris County (the "County"), acting through its Harris County Institute of Forensic Sciences (the "Department") and The University of Texas Health Science Center at Houston ("Contractor"). The County and the Contractor are referred to herein collectively as "Parties" and individually as a "Party."

Recitals

On March 9, 2021, the County and the Contractor entered into a Master Agreement (the "Agreement") to provide a consultant to review CT and radiographic images of child/infant autopsy cases for the Department ("Services").

The Parties desire to amend the Agreement for the first time ("First Amendment") to extend the first term.

Terms

I.

This First Amendment shall be governed by the Master Agreement, which is incorporated herein by reference as though fully set forth word for word.

П.

The Parties agree to extend the first term of the Interlocal Agreement until March 31, 2022.

No additional funds will be appropriated by the County for the extended term.

III.

All other terms and provisions of the Master Agreement shall remain in full force and effect as originally written.

IV.

It is expressly understood and agreed that the Master Agreement is incorporated herein by reference. In the event of any conflict between the terms and provisions of this First Amendment, or any portion thereof, and the terms and provisions of any other part or portion of the Master Agreement, or any

other terms and conditions, this First Amendment shall control.

V.

Execution. Multiple Counterparts: This First Amendment may be executed in several counterparts. Each counterpart is deemed an original. All counterparts together constitute one and the same instrument. Each Party warrants that the undersigned is a duly authorized representative with the power to execute this First Amendment.
