The County Judge thereupon announced that the motion had duly and lawfully carried and that the order had been duly and lawfully adopted. The adopted order follows:

WHEREAS, the County reached a settlement with Greenhouse Road Landfill, LP in regarding technical comments and party status in a contested case hearing before the Texas Commission on Environmental Quality for a vertical and lateral expansion of their Type IV landfill;

WHEREAS, the settlement included improvements to drainage, odor and landfill gas control and monitoring, landfill inspections, waste pick-up patrols and training, \$60,000 in donations to the local school PTAs and a donation of \$10,000 to Harris County.

WHEREAS, residents surrounding the landfill were concerned about hydrogen sulfide (H2S) exposure, in part because TCEQ does not require H2S monitoring at Type IV landfills;

WHEREAS, Harris County Pollution Control Services sampled once for H2S and sample results did not indicate an issue with exposure. However, community concerns remain regarding H2S exposure;

WHEREAS, in order to monitor for H2S and provide additional data to the community regarding H2S exposure, it is proposed to use the \$10,000 to purchase H2S monitoring equipment to test more regularly near the landfill.

**THEREFORE, IT IS ORDERED** the Harris County Commissioners Court hereby authorizes the County Attorney's Office to route the \$10,000 from Greenhouse Road Landfill, LP to PCS for the purchase and operation of H2S monitoring equipment.

All Harris County officials and employees are authorized to do any and all things necessary or convenient to accomplish the purposes of this order.

All fund transfers necessary to accomplish the above are hereby ordered to be made.
