FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN HARRIS COUNTY AND THE CITY OF TOMBALL

THE STATE OF TEXAS

§

COUNTY OF HARRIS

This First Amendment is made and entered into by and between Harris County, Texas, a body corporate and politic under the laws of the State of Texas ("County") acting by and through Harris County Public Health, and the City of Tomball ("City") pursuant to the Interlocal Cooperation Act, Tex. Gov't Code Ann. §§791.001 – 791.030. The County and City are referred to herein collectively as the "Parties" and individually as a "Party".

Recitals

The County, on or around November 7, 2006, entered into an Agreement with City ("Master Agreement") to provide housing and quarantine services for animals found within the city limits of City pursuant to The Rabies Control Act, Chapter 826 of the Texas Health and Safety Code, as amended ("Services").

The Parties now desire to amend the Master Agreement for the first time to increase the amount of money City will pay County for Services ("First Amendment").

Terms

Ī.

The County Executes this First Amendment by and through the County Judge. This First Amendment shall be governed by the Master Agreement which is incorporated herein by reference as if set forth word for word.

Π.

Section VI. of the Master Agreement is hereby amended to read as follows:

For the services agreed to be performed, the City agrees to pay the County Three Thousand and No/100 Dollars (\$3,000.00) per month. The County agrees to send a monthly invoice to the City. Payment for each calendar month during the term of this Agreement must be made by the City to the County by delivering payment to Harris County Veterinary Public Health/Rabies Animal Control, 613 Canino Road, Houston, Texas 77076, on or before the 10th day of each calendar month. Failure to make timely payments results in the immediate termination of this Agreement.

All other terms of the Master Agreement shall remain in full force and effect as originally written and subsequently amended.

IV.

It is expressly understood and agreed that the Master Agreement is incorporated herein by reference. In the event of any conflict between the terms and provisions of this First Amendment, or any portion thereof, and the terms and provisions of any other part or portion of the Master Agreement, this First Amendment shall control.

V.

EXECUTION

Multiple Counterparts: This First Amendment may be executed in several counterparts. Each counterpart is deemed an original. All counterparts together constitute one and the same instrument. Each Party warrants that the undersigned is a duly authorized representative with the power to execute this First Amendment.
