EXECUTIVE SUMMARY

APPROVAL OF THE TEXAS DEPARTMENT OF HOUSING & COMMUNITY AFFAIRS (TDHCA) EMERGENCY SOLUTIONS GRANTS ANNUAL LOCAL GOVERNMENT CERTIFICATION OF APPROVAL FOR NONPROFIT ORGANIZATIONS CONDUCTING ESG SHELTER ACTIVITIES

August 2, 2022

Texas Department of Housing and Community Affairs (TDHCA) has announced the allowance of renewals for ESG Annual funding. As a requirement of the renewal, nonprofit organizations conducting emergency shelter activities must receive approval of their renewed projects from the unit of general local government in which the emergency shelter activities are to be located. Approval is to be documented on the form *Local Government Approval for Shelter Activities*, which must be signed by the county judge (or mayor), or her official designee (such as city manager, assistant city manager, community development director or human services director).

There are five (5) nonprofit organizations requesting approval of the emergency shelter activities for which they are requesting renewals for TDHCA ESG Annual funds. These organizations are:

- The Covenant House Texas (Precinct 1): shelter activities include providing emergency shelter, case management, essential services, access to mainstream benefits, life skills training, transportation, and residential housing placement for 150 clients.
- The Houston Area Women's Center (Precinct 1): shelter activities include providing case management, employment assistance and job training, life skills, childcare, psychotherapy, and shelter operations for 100 clients.
- Magnificat Houses, Inc. (Precinct 1): shelter activities include providing emergency shelter for approximately 14 clients.
- The Salvation Army, a Georgia Corp (Precinct 1): shelter activities include emergency shelter and supportive services for 96 clients.
- Wellsprings Village, Inc. (Precinct 1): shelter activities include case management, transportation, life skills education, mental health services, counseling, employment readiness services, and personal supplies for an estimated 80 clients.

It is recommended that Commissioners Court approve the local government certifications for five (5) nonprofit organizations requesting renewals for TDHCA ESG Annual funds.
