The U.S. Department of the Treasury ("Treasury") issued <u>Reallocation Guidance</u> for the Emergency Rental Assistance (ERA1) program under the Consolidated Appropriations Act, 2021, on October 4, 2021 and updated that Guidance on March 30, 2022.
