Grant Description:

The Texas Legislature, via SB1185, authorizes the use of up to \$5 million in annual state reimbursements for a Mental Health Jail Diversion pilot program. The legislation requires that for every \$2 in program costs, \$1 is reimbursed to the County by the State, and the other \$1, whether cash or in-kind, remain a local unreimbursed cost.
