Grant Description:

Funded by the U.S. Department of Health & Human Services via the Texas Department of Family and Protective Services, the Preparation for Adult Living (PAL) program was implemented in 1986 to ensure that older youth in substitute care are prepared for their inevitable departure from the Texas Department of Family and Protective Services' care and support. Funding sources for the program include PAC 204 (Life Skills Training and Assessment) and PAC 206 (Case Management and Aftercare Services), both of which may be used in support of transitioning foster youth. PAC 206 is funded by the Chafee Foster Care Independent Living program, State general revenue, and/or community match (20%). The Consolidated Appropriations Act, 2021 (H.R. 133) includes \$900 billion in stimulus relief for the COVID-19 pandemic in the United States.

**TEXAS DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES
CONTRACT AMENDMENT**

This Amendment No. 6 (Amendment) bilaterally modifies Contract # HHS000788100001 (Contract) and is entered into by the Texas Department of Family and Protective Services (DFPS) and Harris County (Performing Agency) for Preparation for Adult Living (PAL) Life Skills Training & Assessment and Case Management & Aftercare services.

I. PURPOSE.

As provided for in Section V(A) of the DFPS Interagency and Interlocal Uniform Terms and Conditions, which is incorporated as part of this Contract, the Contract is being modified to increase the budget amount to comply with the Consolidated Appropriations Act, 2021 (P.L. 116-260), extended HR 133, Division X (Supporting Foster Youth and Families Through the Pandemic).

II. CONTRACT MODIFICATIONS.

The Parties agree to amend the following:

- A.** Section IV (Total Amount of This Contract) of this Contract to increase the budget by \$300,000.00 for the purpose of providing financial assistance to eligible youth/young adults approved by DFPS PAL Staff.
- B.** Unless otherwise modified by this Amendment or any prior Amendments, this Contract will remain in full force and effect.

III. EFFECTIVE DATE.

This Amendment is effective upon execution and ends on September 30, 2022.

IV. SIGNATORIES.
