## THIRD AMENDMENT TO AGREEMENT BETWEEN HARRIS COUNTY AND ML FORENSIC CONSULTING LLC

THE STATE OF TEXAS

COUNTY OF HARRIS

§ §

This Third Amendment to Agreement Between Harris County and ML Forensic Consulting LLC is entered into by and between Harris County (the "County"), a body corporate and politic under the laws of the State of Texas, acting by and through the Harris County Institute of Forensic Sciences ("Department"), and ML Forensic Consulting LLC ("Contractor").

WHEREAS, on March 22, 2022, the County and Contractor entered into an agreement (the "Agreement") for the Contractor to provide medical examiner services for the County, including medicolegal exams of decedents requiring autopsies:

WHEREAS, the Agreement was previously amended to clarify the payment arrangements and to remove the restriction on the number of autopsies the Contractor is allowed to perform each month:

WHEREAS, the Agreement was amended a second time to extend the time for providing autopsy reports and provide for payment of 90% of the Contractor's fee following completion of an autopsy; and

WHEREAS, the parties wish to amend the Agreement a third time to appropriate an additional \$100,000.00 to pay for services provided by the Contractor under the terms of the Agreement.

THEREFORE, County and Contractor hereby agree to amend the Agreement in the following respects:

I.

Paragraph 6) A) under the heading "Limit of Appropriation" is hereby modified to read as follows:

A) Contractor understands and agrees, said understanding and agreement also being of the absolute essence of this Agreement, that the total maximum compensation that Contractor may become entitled to for the Services performed under this Agreement, and the total maximum sum that the County shall become liable to pay to Contractor under this Agreement, shall not under any conditions, circumstances, or interpretations thereof exceed the sum of Two-Hundred Thirty-Two Thousand and No/Dollars (\$232,000.00). Notwithstanding anything to the contrary, or that may be construed to the contrary, the County's liability under the terms and provisions of this Agreement is limited to this sum.

II.

Attachment 1-B affixed to this Third Amendment shall replace Attachment 1-A to the Agreement.

III.  All other terms and provisions of the Agreement shall remain in full force and effect.
