# Harris County application to the U.S. Department of Transportation (DOT) for FY 2022 Safe Streets for All (SS4A) Implementation Grant

#### **Application Synopsis:**

SS4A is a discretionary grant program providing up to \$30 million per application for Fiscal Year 2022 in dedicated funding to support regional and local projects and strategies that will prevent roadway deaths and serious injuries in the applicant's jurisdiction. The Harris County application includes twelve corridor safety projects that are in the top 20 percent of the roadway segments in the County's High Injury Network (HIN). The HIN is ranked by the number of fatalities and serious injuries in crashes for cars, bicyclists, and pedestrians. The twelve project locations included in the County's SS4A Implementation Grant Application are selected based on the corridor's high number of fatalities and injuries and the high percent of population in DOT's disadvantaged census tracts, which is an important application scoring criteria by DOT. The corridor safety improvements in the County's proposed projects include raised medians, bike lanes, sidewalks, roadway reconfigurations, access management, and intersection improvements.

The submission of this application will allow Harris County the opportunity to obtain \$30 million in federal grant funding with a local match of \$7.5 million to design and construct roadway safety projects which will help achieve the County's Vision Zero initiative to eliminate deaths and serious injuries from traffic crashes by 2030. The implementation of the proposed projects will create safe roadways for pedestrians, bicyclists, and car drivers. The implementation timeline for this grant is within five years after the establishment of a grant agreement.

Traffic crashes are a major cause of accidental deaths in Harris County. From 2014-2018, there were on average 430 crashes where someone was killed and 2,278 crashes where someone was seriously injured in Harris County each year. This equates to someone dying in a traffic crash every day, and at least five people severely injured every day. Harris County has developed the High Injury Network (HIN) comprised of roadway segments on unincorporated Harris County roadways with 3.5 or more severe or fatal crashes per mile. Collectively, these roadway segments make up 5.3% of the unincorporated Harris County roadway network but account for 60% of severe or fatal crashes. The HIN was created utilizing the 5-Year dataset from the Texas Department of Transportation (TxDOT) Crash Records Information System (CRIS), which included vehicular crash analysis for all single or multiple vehicle crashes that resulted in a fatality or incapacitating injury as well as pedestrian and bicycle crash analysis for crashes that included pedestrian and bicyclist fatality or incapacitating injury.

The Vision Zero implementation projects identified in this application are in the top 20 percent highest ranked (by KSI) roadway segments on the HIN and will improve safety conditions to reduce fatality and serious injury crashes on 30.8 miles of corridors. These twelve corridors are selected based on logical project limits and include the highest ranked HIN segments, as well as lower ranked segments on the HIN in close proximity to the highest ranked segments. To determine logical project limits and propose effective safety countermeasures based on roadway and crash characteristics, crash trends were evaluated for the 5-year period of 2014-2018 as well as for the 3-year period of 2019-2021. This crash

data evaluation combined with information gathered from Harris County Engineering Department staff on existing and planned capital improvement projects and intersection safety studies was utilized to address the continued risk of fatal and serios injury crashes occurring on the identified corridors.

Each corridor has been evaluated based on existing roadway cross-section, daily traffic volumes, and predominant crash characteristics to identify applicable safety countermeasures. The safety countermeasures proposed in these projects are based on the Federal Highway Administration's (FHWA) collection of Proven Safety Countermeasures to ensure significant and measurable impacts in reducing fatalities and serious injuries for motorists, pedestrians, and bicyclists. Specifically, these countermeasures will address roadway safety challenges identified in the crash contributing factors for Harris County, such as speeding, intersection-related roadway departure, poor lighting, or pedestrian/bicyclist-related crashes resulting in a significant reduction in traffic crashes on the implementation project corridors.
