BE IT ORDERED, that the Commissioners Court of Harris County, Texas hereby ratifies a tax rate for 2022 established pursuant to Section 26.05(c) of the Texas Tax Code, acting for and on behalf of the Harris County Flood Control District, that a tax rate for 2022 for the Harris County Flood Control District of Harris County, Texas of \$0.03476 be hereby adopted and fixed for the specific purposes and funds and at the rates hereinafter listed, and that there be, and there are hereby adopted, imposed, levied and assessed for the year 2022 on each one hundred dollars valuation of all property in the Harris County Flood Control District of Harris County, Texas whether real, personal, or mixed, cash value thereof estimated in lawful money of the United States, owned in the Harris County Flood Control District of Harris County, Texas, on January 1,

2022, (except so much thereof as may be exempt by virtue of the Constitution and laws of the State of Texas) taxes for the following funds and purposes and at the following rates on the one hundred dollars valuation of property:

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.49 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$-1.36.

It is further ordered that said taxes be assessed and collected by the Assessor and Collector of Taxes charged with such duties, at the time and in the manner prescribed by law, and applied to the purposes named and as authorized by the Constitution and laws of the State of Texas.
