SETTLEMENT AGREEMENT

THE STATE OF TEXAS §

COUNTY OF HARRIS §

This Settlement Agreement ("Agreement") is executed by and between Harris County (the "County") and Meals on Wheels Montgomery County ("MOWMC"). The County and MOWMC are referred to herein collectively as "Parties" and individually as a "Party."

The County engaged in providing non-emergency transportation services for MOWMC without an Agreement in place (the "Services"). MOWMC is willing to pay The County for the Services received during the period from January 1, 2022, to February 1, 2022.

WHEREAS, the Parties hereto agree to settle the outstanding issues between them as follows:

I. Incorporation of Documents

The County's invoice for the Services is attached hereto as Exhibit A and incorporated herein by reference.

II. Consideration

As full compensation for the benefits of this Agreement, MOWMC agrees to pay Twenty-Two Thousand Twenty-One and 92/100 Dollars (\$22,021.92) the County for the reimbursement of costs incurred as a result of the Services.

III. Miscellaneous

This instrument, together with the instruments incorporated herein by reference, contains the entire Agreement between the Parties relating to the rights herein granted and the obligations herein assumed. Any oral representations or modifications concerning this instrument shall be of no force or effect. Only a written instrument executed by representatives duly authorized by the governing body of the County or legal representatives of the Parties hereto may amend this Agreement.

The Parties intend that if, for any reason, any specific part, term, paragraph or provision of this Agreement is determine to be illegal or invalid, in whole or in part, then the remaining valid and legal portions of the Agreement shall continue in full effect and shall be fully enforced.

This Agreement shall be governed and construed in accordance with the laws of the State of Texas and any applicable Federal laws, regulations and policies. In the event of any dispute arising under this Agreement, venue shall be proper in a court of competent jurisdiction in Houston, Harris County, Texas, exclusively.

Nothing herein shall be construed as creating any personal liability on the part of any official, officer, employee, agent, representative, attorney or any other person acting for or on behalf of the County.

IN WITNESS WHEREOF, this instrument has been executed in duplicate originals, each of equal force, on behalf of the County by a duly authorized representative of the County pursuant to the approval of the Harris County Commissioners Court, and by a duly authorized representative of MOWMC.
