# MEMORANDUM OF UNDERSTANDING BETWEEN HARRIS COUNTY SHERIFF'S OFFICE AND HARRIS COUNTY COMMISSIONER PRECINCT 4

This Memorandum of Understanding (MOU) sets forth the terms and understanding between Harris County Sheriff's Office ("HCSO"), and Harris County Commissioner Precinct 4 ("P4"), in cooperative agreement to provide and fund law enforcement services. HCSO and P4 are referred to herein collectively as "Parties" and individually as a "Party."

# A. PURPOSE OF MOU

The purpose of this MOU is to set forth responsibilities between HCSO and P4 for the provision of law enforcement services (the "Services").

## B. TERMS OF MOU

This MOU shall commence upon approval of Commissioners Court and shall automatically renew each year, unless terminated by either party.

#### Agreements of Parties:

# HCSO hereby agrees:

- 1. To provide deputies ("HCSO Personnel") to P4 for the purpose of providing the Services as needed for 40 hours per week Monday through Friday plus overtime if necessary.
- 2. To provide P4 documentation for the actual cost of the HCSO Personnel.

## P4 hereby agrees:

- 1. To provide funding for 100% of the HCSO Personnel's salary, including fringe benefits, plus associated vehicle costs upon the execution of this MOU. Overtime worked will need to be reimbursed as incurred.
- 2. HCSO Personnel will remain under full and total control of HCSO.

<u>Termination</u>. This MOU may be terminated by either Party for any reason after 30 days written notice.

<u>Entire Agreement</u>. This MOU contains the entire agreement of the parties and may be modified only by written amendment executed by both Parties.

<u>Multiple Counterparts/Execution</u>. This MOU may be executed in several counterparts. Each counterpart is deemed an original and all counterparts together constitute one and the same instrument. In addition, each Party warrants that the undersigned is a duly authorized representative with the power to execute the MOU.
