## Grant Discussion:

The County previously received installments totaling \$72,780,379.23 under the Emergency Rental Assistance (ERA2) program. The purpose of this item is to request Court acceptance an additional award of \$1,326,429.89, which will bring the grant total received to \$74,106,809.12. Note: This award is less than the supplemental \$24,000,000 requested, but reflects the amount available for distribution in this round of funding. The County will act as an intermediary to administer and direct the allocation of these funds to eligible households unable to pay rent and utilities due to the COVID-19 pandemic. There is no match requirement.
