IT IS ORDERED that the County Attorney is authorized to file the lawsuits described on the attached matrix and to expend the listed sums to pay the necessary expenses incurred in preparation, pre-trial, trial, and appeal of each case. The County Attorney is empowered to employ and pay all discovery costs, court reporters, appraisers, expert witnesses, consultants, and anyone else deemed necessary to bring each case to final judgment. The County Attorney is authorized to incur and pay all travel expenses of County employees, witnesses, and all other individuals deemed necessary for the preparation and testimony in regard to the matters described in the attached matrix. All such expenditures shall be made in accordance with Harris County Policies and Procedures. Funds shall be transferred from the indicated fund.

The County Attorney is authorized to settle or compromise all suits seeking monetary damages on terms and conditions found by the County Attorney to be in the best interest of Harris County for all claims for damages totaling \$25,000 or less.

The County Attorney is authorized to join any and all parties he deems proper, to do any and all things reasonable and necessary to compel compliance with the law and to finally dispose of suits by obtaining compliance and civil penalties as authorized by applicable law, as he deems appropriate.
