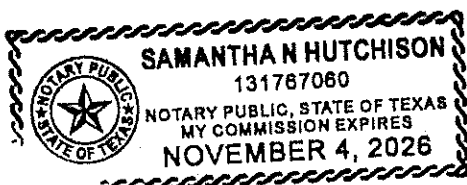


On my honor, I will never betray my badge, my integrity, my character, or the public
