RECITALS:

WHEREAS, Section 396.041 of the Texas Transporation Code sets forth county regulations pertaining to Junkyards or Automotive Wrecking and Salvage Yards;

WHEREAS, Harris County Commissioners Court adopted and approved the Ordinance of Harris County, Texas, Regarding Licensing of Junkyards and Automotive Wrecking and Salvage Yards on September 15, 2009 ("Ordinance") and subsequently adopted and approved amendments to the Ordinance on September 15, 2009, September 1, 2013, and May 11, 2021.

WHEREAS, Harris County Commissioners Court now desires to further amend the Ordinance to designate the County Engineer with authority to approve applications to operate a junkyard or automotice wrecking and salvage yard at a location; and

WHEREAS, Harris County Commissioners Court desires to set a public hearing date concerning the proposed revisions to the Ordinance and further desires that the Harris County Engineering Department post and publish a notice of such hearing in accordance with Section 396.043 of the Texas Transporation Code.

IT IS ORDERED that:
