FIFTH AMENDMENT TO THE AGREEMENT BETWEEN HARRIS COUNTY AND CARING COMMERCIAL CLEANING, INC.

THE STATE OF TEXAS § COUNTY OF HARRIS §

This Fifth Amendment to the Agreement is made and entered into by and between Harris County (the "County"), acting through Harris County Facilities and Property Management (the "Department") and Caring Commercial Cleaning, Inc. ("Contractor"). The County and the Contractor are referred to herein collectively as "Parties" and individually as a "Party."

Recitals

On January 6, 2015, the County and the Contractor entered into a Master Agreement (the "Agreement") for custodial cleaning services at Region 2.

The Parties have amended the Agreement multiple times to extend the term.

The Parties desire to extend the Agreement for the fifth time ("Fifth Amendment") for the purpose of extending the term and appropriating additional funds.

Terms

I.

This Fifth Amendment shall be governed by the Master Agreement and previous amendments, which are incorporated herein by reference as though fully set forth word for word.

II.

The current term of the Master Agreement is extended until October 4, 2023, or until a new Agreement is in place.

III.

For the extended term, the County hereby amends the Master Agreement to add Three Hundred and Sixty Thousand and No/Dollars (\$360,000.00).

IV.

All other terms and provisions of the Master Agreement shall remain in full force and effect as originally written.

V.

It is expressly understood and agreed that the Master Agreement is incorporated herein by reference. In the event of any conflict between the terms and provisions of this Fifth Amendment, or any portion thereof, and the terms and provisions of any other part or portion of the Master Agreement, previous amendments, or any other terms and conditions, this Fifth Amendment shall control.

VI.

Execution. Multiple Counterparts: This Fifth Amendment may be executed in several counterparts. Each counterpart is deemed an original. All counterparts together constitute one and the same instrument. Each Party warrants that the undersigned is a duly authorized representative with the power to execute this Fifth Amendment.

The County Judge thereupon announced that the motion had duly and lawfully carried and that the order had been duly and lawfully adopted. The order thus adopted follows:

IT IS ORDERED that County Judge Lina Hidalgo be, and is hereby, authorized to execute for and on behalf of Harris County, the Fifth Amendment to the Agreement between Harris County and Caring Commercial Cleaning, Inc.; for the purpose of extending the current term until October 4, 2023, or until a new Agreement is in place; for an additional Three Hundred and Sixty Thousand and No/Dollars (\$360,000.00) in appropriated funds; under the same terms and conditions specified in the Master Agreement and this Fifth Amendment. The Master Agreement and Fifth Amendment are incorporated herein as though fully set forth word for word.

All Harris County officials and employees are authorized to do any and all things necessary or convenient to accomplish the purpose of this Order.
