



RESOLUTION

WHEREAS, The Texas Legislative Internship Program (TLIP) was established by then State Senator and now Commissioner Rodney Ellis in December 1990, and it is administered by the Texas Southern University Foundation. Inspired by The Honorable Mickey Leland’s commitment to develop future leaders in public service, the program provides undergraduate, graduate, and law students the unique opportunity to serve as interns in the Texas Legislature, the United States Congress, local government, and a variety of public policy organizations; and
