**THIS FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT** ("First Amendment") made and entered into pursuant to the Interlocal Cooperation Act (TEX. GOV'T CODE ANN. Ch. 791) by and between the **CITY OF HOUSTON, TEXAS** (the "City"), a home-rule city of the State of Texas principally situated in Harris County, by and through its **Houston Health Department** ("HHD"), and **HARRIS COUNTY** (the "County"), a body corporate and politic under the laws of the State of Texas. The terms of this First Amendment shall be effective as of the date of countersignature by the City Controller herein (the "Effective Date"). The Parties to this Agreement may be referred to singly herein as a "Party" or collectively as the "Parties".

**RECITALS:**

**WHEREAS**, HHD entered into an Agreement to pay the County to use the EIP Data Integration Project that the County is currently in an agreement with Educational Results Partnership to provide technology consulting services for completing and maintaining the EIP Data Integration Project environment for the County (the "Original Agreement") (Contract No. C79989);

**WHEREAS**, HHD and the County now desire to add to the Original Agreement Exhibit A which detail the Cost Schedule;

**NOW, THEREFORE**, for and in consideration of the mutual promises, covenants, agreements, and benefits contained in the Original Agreement and this First Amendment, HHD and the County agree as follows:

**ARTICLE I.**

The attached Exhibit A of this First Amendment is hereby added to the Original Agreement.

**ARTICLE II.**

All other terms and conditions of the Original Agreement, except as amended in this First Amendment, shall continue in full force and effect. In the event of a conflict between the Original Agreement and this First Amendment, this First Amendment shall prevail.

Each person signing this First Amendment represents and warrants that he or she is duly authorized and has legal capacity to execute and deliver this First Amendment. The Parties hereby agree that each Party may sign and deliver this First Amendment electronically or by electronic means and that an electronic transmittal of a signature, including but not limited to, a scanned signature page, will be as good, binding, and effective as an original signature.
