Recitals:

1. On September 28, 2021, Harris County entered into an agreement (the “Contract”) with Cartegraph Systems, LLC to provide Work Order Management System and Related Services for Harris County. Cartegraph Systems, LLC now desires to assign the remainder of the Contracts to OpenGov.
2. OpenGov is a separate company from Cartegraph Systems, LLC as evidenced by Acquisition Letter, attached hereto as Exhibit A.
3. The assignment shall begin upon approval by Commissioners Court and remain in effect until completion of the services.

IT IS ORDERED that:

1. The recitals set forth in this Order are true and correct.
2. The Harris County Commissioners Court authorizes the assignment of the rights, duties and privileges under the Contracts from Cartegraph Systems, LLC to OpenGov.
