I write to you as Director of the Mayor's Office for People with Disabilities (MOPD) and on behalf of our event partner, the Texas Workforce Solutions Gulf Coast Region to announce that we are organizing a major employer and community resource event for Wednesday, May 15, 2024, from 10 AM – 2 PM. Given the overwhelming interest, the event has outgrown its initial venue (**Metropolitan Multiservice Center**), and we are now relocating to a larger venue (**University of Houston – Main Campus**).

This employer and community resource event will be unlike any other hiring fair previously hosted, as we are extending invitations to all 13 regions that make up the Gulf Coast, including Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton. Additionally, we are inviting students from all UH campuses to attend.
