On Harris County's behalf, I am requesting a no-cost extension for our Safety + Justice Challenge Sustainability grant (G-1705-154130) with the MacArthur Foundation. The funding currently expires on February 29, 2024. If approved, the new end date will be February 28, 2025.

The status of the grant funds (see the attached spreadsheet, SJC Sustainability Budget) is as follows:

- To date, \$228,300 of grant funds have been used on expanded RIC docket support, community engagement grants, racial and ethnic equity education/training, and travel to the all-sites network meeting.
- \$271,650 is encumbered for the final award of community engagement grants approved by the
