Recitals:

1. On August 8, 2023, Harris County entered into an agreement (the "Contract"), Job No. 230187, with NBG Constructors to provide construction of a pedestrian bridge near the Hill at Sims Park for Harris County Precinct 1. NBG Constructors now desires to assign the remainder of the Contracts to Main Lane Industries Ltd.

2. Main Lane Industries Ltd. acquired the construction business of NBG Constructors as evidenced by the Assumed Name Certificate attached hereto.
