Mays Survey, Abstract No. 543, Harris County, Texas, being more particularly described as an 8.790 acre $\mathbf{( 3 8 2 , 8 9 6}$ square feet) tract of land identified as Tract " $A$ " herein, and 1.998 acre ( 87,034 square feet) tract of land identified as Tract " $B$ " herein, said lands being more particularly depicted and described by metes and bounds on Exhibit "A" attached hereto and made a part hereof.

This conveyance is made by Grantor and accepted by the Grantee subject to all requirements of Local Government Code $\S 272.001(1$.$) , and subject to all valid and subsisting encumbrances, conditions,$ covenants, restrictions, reservations, exceptions, rights-of-way, and easements appearing of record in the Official Public Records of Real Property of Harris County, Texas, relative to the above-described property. Grantor and Grantee acknowledge and agree that the property herein conveyed shall be used only for flood control, drainage maintenance, and related purposes. If the property herein conveyed ceases to be used for flood control, drainage maintenance, or related purposes, then title to the property shall revert to Grantor without any further action by Grantor.

TO HAVE AND TO HOLD the above described premises, together with all and singular the rights and appurtenances thereto in anywise belonging unto the said Grantee, Grantee's successors and assigns, forever, and Grantor does hereby bind Grantor, Grantor's successors, and assigns to Warrant and Forever Defend all and singular the said premises unto the said Grantee, Grantee's successors and assigns, against every person whomsoever lawfully claiming, or to claim the same, or any part thereof, by, through or under Grantor, but not otherwise, except as to the reservations from and exceptions to warranty and conveyance described above.
