By graphical plotting and according to FIRM Map Number 48201C0705M for Harris County, Texas and Incorporated Areas (Map revised January 6, 2017) the tract of land shown herein is situated in the following flood zone: Zone "X" unshaded, Zone "X" unshaded is defined as "Areas determined to be outside the 0.2% annual chance flood plane" "LJA does not warrant nor subscribe to the accuracy or scale of said maps".

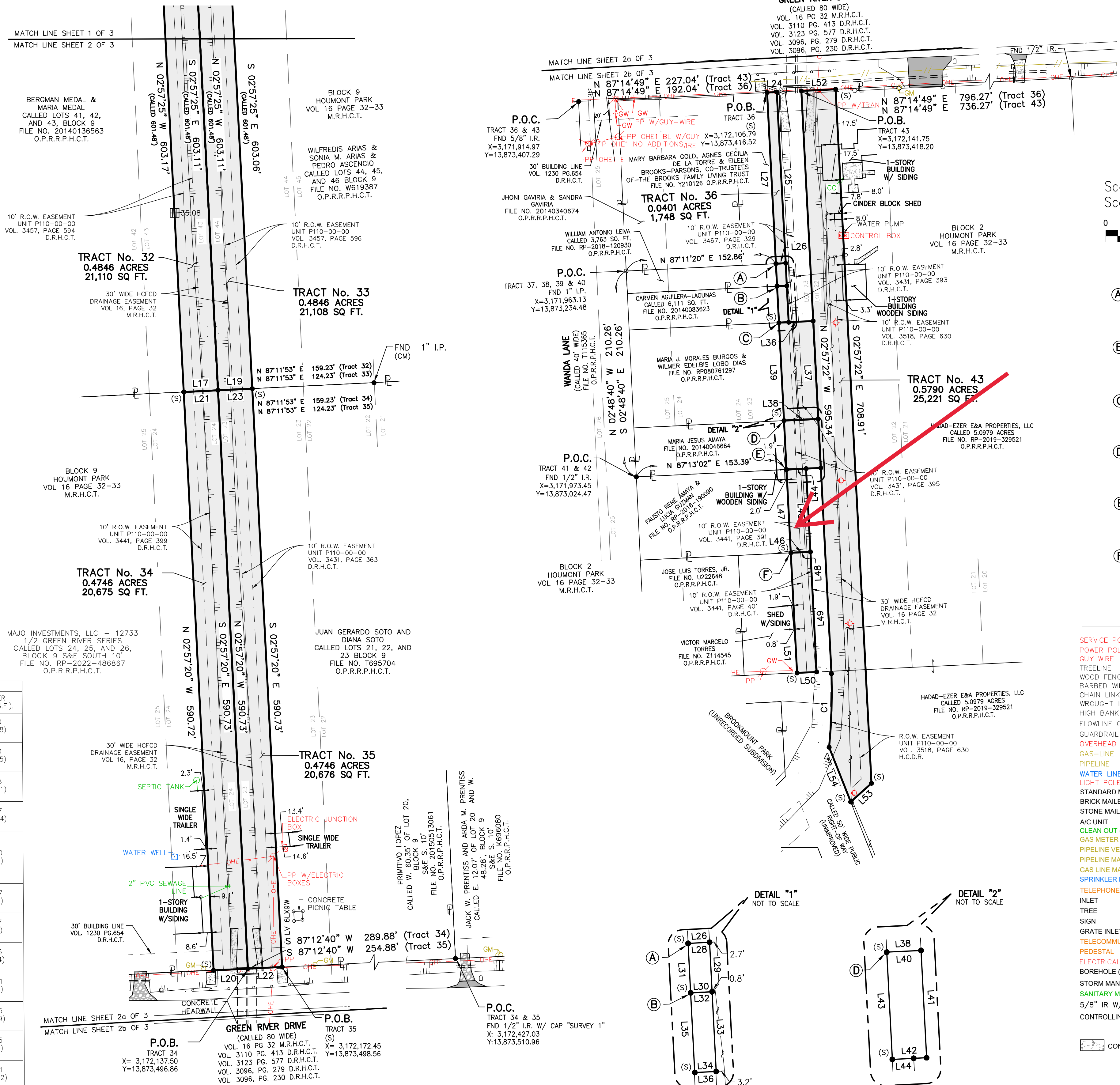
