
**DISTRICT JUDGE ORDER TO APPROVE
COURT REPORTERS
ANNUAL COMPENSATION**

1. Approval of the Court Reporters Annual Compensation for District, County and Probate Courts for the fiscal year ending September 30, 2025, as set out is hereby granted.
2. A public hearing, as required by Section 152.905 of the Local Government Code, must be held before settling the amount of annual compensation of the Court Reporters.
3. The annual compensation of the Court Reporters is set at \$129,417.60.
4. In the event a cost of living increase is granted by Commissioners Court to other County employees subsequent to the public hearing, the County Auditor is hereby given authority to increase the maximum salaries contained herein (limited to the cost of living percentage granted by Commissioners Court).

This order shall remain in effect unless altered or amended by a vote of the District Judges or by the law.

Duly put before the Board of District Judges and carried that the Court Reporters Compensation for fiscal year ending September 30, 2025, is hereby approved by the Board of District Judges.
