FIRST AMENDMENT TO THE AGREEMENT BETWEEN HARRIS COUNTY AND SONDER USA, INC.

THE STATE OF TEXAS
COUNTY OF HARRIS

This First Amendment to the Agreement is made and entered into by and between Harris County (the "County") through its Community Services Department (the "Department") and Sonder USA, Inc. (the "Contractor"). The County and the Contractor are known individually as "Party" and collectively as "Parties".

Recitals

On May 6, 2020, the Parties executed an agreement (the "Master Agreement") with the County authorizing the application of CDBG-DR grant funds for the provision of temporary housing for those being temporarily removed from their homes pursuant to certain County programs, an eligible activity under the rules and regulations regarding CDBG Program Grant Funds (the "Services").

The Parties now desire to amend the Master Agreement to remove all references to the Homeowners Assistance Program.

Terms

I.

Section I(A) of the Master Agreement is hereby modified to read as follows:

"A) Contractor agrees to provide temporary lodging on behalf of the Department, as detailed herein and in the Request for Proposal ("RFP") Purchasing Job No. 19/0322, (the "Services"), attached hereto as Exhibit A and incorporated herein by reference. The Parties acknowledge that the Services requested herein are on an asneeded basis and there is no guaranty or minimum threshold of Services to be provided during the term. The Services are being provided to the County as a part of, and integrated with the Disaster Recovery Buyout Program."

II.

Any other references within the Master Agreement to the "Homeowners Assistance Program" or "HAP" are hereby similarly deleted and of no further force or effect.

In the event of any conflict between the term and provisions of this First Amendment, or any portion thereof, and the terms and provisions of any other part or portion of the Master Agreement, this First Amendment shall control.

IV.

All other terms and provisions of the Master Agreement shall remain in full force and effect as originally written and subsequently amended.

V.

EXECUTION

Multiple Counterparts: This First Amendment may be executed in several counterparts. Each counterpart is deemed an original. All counterparts together constitute one and the same instrument. Each Party warrants that the undersigned is a duly authorized representative with the power to execute this First Amendment.
