Benito Guerrier, AIA

Benito Guerrier is an accomplished architect with more than 30 years of experience, he serves as Executive Vice President and Director of Government Project at Kirksey Architects, one of Houston's largest and most successful architectural firms. His portfolio of work includes projects in Texas, Colorado, Florida as well international projects in Mexico, Colombia & Venezuela.

As a civic leader he has served on numerous boards and associations including: the Houston Parks Board for 10 years, where he participated in the creation on implementation of the Bayou Green Ways. He also Chair the committee to save and renovate the 1908 Gus Wortham Golf course, the first 18 holes golf course in the state of Texas.
