FIRST AMENDMENT TO THE AGREEMENT BETWEEN HARRIS COUNTY AND PIVOT TECHOLOGY SERVICES CORP.

THE STATE OF TEXAS § §

COUNTY OF HARRIS

This First Amendment to the Agreement is made and entered into by and between Harris County (the "County"), a body corporate and politic under the laws of the State of Texas and acting by and through Harris County Toll Road Authority ("HCTRA"), and Pivot Technology Services Corp. ("Contractor"). The County and Contractor are known individually as a "Party" and collectively as "Parties."

Recitals

On May 10, 2016, the County entered into an agreement with the Contractor to provide Oracle products, services and solutions to HCTRA, as detailed in RFP Job No. 16/0037 (the "Agreement").

Both the County and Contractor desire to amend the agreement for the First time to add a one (1) year renewal option ("First Amendment").

Contractor warrants and represents that it is willing and capable of providing the services.

Terms

Ī.

This First Amendment shall be governed by the Agreement and the RFP Job No. 16/0037, which are incorporated by reference as though fully set forth word for word.

II.

The term of the Agreement is hereby amended to add a one (1) year renewal option.

III.

It is expressly understood and agreed that the Agreement is attached to this First Amendment and incorporated herein by reference. In the event of any conflict between the terms and provisions of this First Amendment, or any portion thereof, and the terms and provisions of any other part or portion of the Agreement, this First Amendment shall control.

V.

All other terms and provisions of the Agreement shall remain in full force and effect as originally

written and subsequently amended.

VI.

Execution, Multiple Counterparts: This First Amendment may be executed in several counterparts. Each counterpart is deemed an original. All counterparts together constitute one and the same instrument. Each Party warrants that the undersigned is a duly authorized representative with the power to execute this First Amendment.
