### MEMORANDUM OF UNDERSTANDING BETWEEN THE

### HARRIS COUNTY FLOOD CONTROL DISTRICT AND NATIONAL OCEANIC AND ATMOSPHERIC ADMINISTRATION/NATIONAL WEATHER SERVICE

# FOR ASSISTANCE IN COLLECTING AND MEASURING HIGH WATER MARKS AND OTHER ASSOCIATED IMPACTS RELATED TO FLOODING, IN PARTICULAR TROPICAL CYCLONES

WHEREAS, the Harris County Flood Control District (District) desires to assist the National Oceanic and Atmospheric Administration/National Weather Service (NOAA/NWS), by providing equipment and expertise to mark and measure high water marks during storm events nationwide with a focus on storm surge and wave run-up; and

WHEREAS, the NOAA/NWS desires the District's expertise to document storm surge and associated inland flooding to improve the accuracy of the historical record and better calibrate forecasts/models to improve future flood forecasts and messaging, and ultimately reduce flood loss from future storms and tropical cyclones; and

WHEREAS, NOAA/NWS is responsible for weather forecasts and attempts to verify flooding associated with landfalling tropical cyclones along the coast of the United States; and

WHEREAS, the District, a conservation and reclamation district authorized by the Texas Legislature and whose mission is to provide flood damage reduction projects that work, with appropriate regard for community and natural values, is responsible for collecting high water marks in Harris County from inland flooding and inundation near Galveston Bay and can provide expertise and equipment support (assistance) to other areas of the United States related to storm surge; and

WHEREAS, the NWS requests the District's assistance in other areas of the country if those services are needed and only if the District is able to provide the support and there are no forecasted severe weather impacts to the Harris County area, including the threat of a tropical cyclone in the Gulf of Mexico; and

**WHEREAS**, the District desires to volunteer its expertise and equipment to help NOAA/NWS and will pay its own costs incurred in providing this assistance; and

WHEREAS, this non-binding Memorandum of Understanding ("MOU") documents the intentions of the District to assist NOAA/NWS if requested and if able, at the sole discretion of the District.
