THIS FIRST AMENDMENT TO A RIGHT OF ENTRY AGREEMENT is made, entered into, and executed by and between the Harris County Flood Control District, a body corporate and politic under the laws of the State of Texas, hereinafter referred to as "HCFCD" or the "District", and the City of Houston, a municipal corporation and home rule city of the State of Texas, principally situated in Harris County, acting by and through its City Council, hereinafter referred to as the "City."

WHEREAS, the District and the City previously entered into the Agreement, countersigned by the City Controller on April 13, 2009, and executed by the District on February 24 2009, hereinafter referred to as the "Original Agreement," to construct channel improvements on Brays Bayou, HCFCD Project ID D100-00-E006, hereinafter called the "Project"; and

WHEREAS, the City owns or has easement rights in real property in Harris County, Texas, and is willing to allow the District to use the portion of the Premises owned in fee by the City for development and maintenance; and

WHEREAS, the District desires to amend the Original Agreement to extend the active construction date.

NOW, THEREFORE, for and in consideration of the mutual covenants, agreements, and benefits to the parties herein named, the parties agree as follows:

 Section titled "Construction of the Project" Paragraph 8 of the Original Agreement is hereby amended to read as follows:

For purposes of constructing the Project, the right of entry granted for construction of the Project will terminate upon completion of the Project and removal of all construction materials, supplies, vehicles, staging, and storage facilities from the Land, but in any event will not continue beyond December 31, 2022, unless the Parks Director extends such date in writing.

 Exhibit "E" shall be added to the Original Agreement to show additional lands as noted on Project ID D100-00-00-B008, comprising Land subject to the terms of this Agreement.

All other terms and conditions of the Original Agreement which are not changed by this First Amendment remain in full force and effect and together with this First Amendment shall be the Agreement.




