
The Harris County Housing Authority (“HCHA”) has partnered with Atlantic Pacific, LLC to develop a 288-unit affordable housing development (“Project”) to be located on the Southwest corner of Jones Road and Grant Road, Houston, Harris County, Texas 77429. The Project will be financed with a combination of 4% housing tax credits and tax-exempt bonds issued by HCHA’s affiliate entity, Harris County Housing Authority Public Facility Corporation (“Issuer”). The Issuer is required to hold a public hearing pursuant to the Tax Equity and Fiscal Responsibility Act of 1982 (“TEFRA”) and the TEFRA hearing must then be approved by the chief elected executive officer or the elected legislative body of that jurisdiction.

I am writing to request your approval of the TEFRA hearing for the Project which was duly held on May 27, 2021 in accordance with the TEFRA requirements. I have attached for your review and execution the Certificate of County Judge. This certificate is accompanied by the following supporting documentation: (1) Affidavit of Publication; (2) Copy of published notice (3) Script of TEFRA hearing reflecting comments, if any; and (4) Sign-in sheet of attendees

If these documents are acceptable, we request that this item be placed on the next Commissioner’s Court agenda for approval and execution.

TEFRA HEARING SCRIPT
The Residences at Arbor Oaks
May 27, 2021

Good evening. My name is Horace Allison. I would like to proceed with the public hearing. Let the record show that it is ^{5:31}____PM, Thursday, May 27, 2021, and we are at the Harris County Housing Authority, located at 1933 Hussion St., Building 3, Houston, Texas. I am here in person to conduct the public hearing on behalf of Harris County Housing Authority Public Facility Corporation with respect to an issue of tax-exempt multifamily revenue bonds for a residential rental community. This hearing is also available to the public via telephone as provided in the public notice. This hearing is required by the Internal Revenue Code. The purpose of this hearing is to provide a reasonable opportunity for interested individuals to express their views regarding the development and the proposed bond issue.

No decisions regarding the development will be made at this hearing.

The Bonds will be issued as tax-exempt multifamily revenue bonds in the aggregate principal amount not to exceed \$20,000,000 and taxable bonds, if necessary, in an amount to be determined and issued in one or more series by Harris County Housing Authority Public Facility Corporation. The proceeds of the Bonds will be loaned to The Residences at Arbor Oaks, LP (“Borrower”), to finance a portion of the costs of the acquisition, constructing, and equipping of a multifamily rental housing community containing 192 units to be located at the Southwest intersection of Jones Road and Grant Road, Houston, Texas. The proposed multifamily rental housing community will be initially owned and operated by the Borrower.

I would now like to open the floor for public comment.

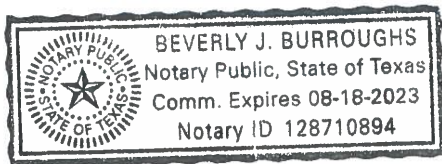
1. Harris County Housing Authority ("HCHA") is a housing authority who has jurisdiction throughout Harris County, Texas.



Notice is hereby given of a public hearing to be held by the Harris County Housing Authority Public Facility Corporation (the "Issuer"), **on Thursday, May 27, 2021, at 5:30 p.m. via videotelephony conferencing (access information outline below)**, with respect to an issue of multifamily housing revenue bonds (the "Bonds"), to be issued by the Issuer in one or more series of tax-exempt bonds in an aggregate principal amount not to exceed \$20,000,000. The proceeds of the Bonds will be loaned to The Residences at Arbor Oaks, L.P. (or a related person or affiliate thereof, the "Borrower"), to finance a portion of the costs of development and construction of a multifamily residential rental development known as Residences at Arbor Oaks (the "Development"), containing approximately 192 units and to be located near the southwest corner of the intersection of Grant Road and Jones Road (near the SW Corner), Houston ETJ, Harris County, Texas 77070. The Development will be initially owned by the Borrower.

All interested persons are invited to attend such public hearing to express their views with respect to the Development and the issuance of the Bonds or submit comments in advance of the hearing at events@hchatexas.org.
