## **Department's Head Justification for the Increase**

"The intention of the petty cash increase is to cover parking and food/snack expenses incurred due to the Civil Service Commission hearings. A rotation of (3) commissioners preside currently over (20) hearings per month. The parking expense is \$36 or \$60 (Astro's game day) for each hearing. The docket of (5) hearings last all-day [9am-5:30pm]. Because of this all-day commitment, the Civil Service Commission would like to provide lunch for the appointed commissioners. The current petty cash allocation (\$50.00) cannot meet the expenses of the department. The past practice by the former director was to reimburse the commissioner's parking with his own funds."
