
Purpose


Grant Requirements

1. Grant funds must be used for Region 4 ESC training, products, or services. Expenditures may include training fees, training materials, customized contracts, conference registrations, products, or other services from Region 4.
2. The charter school superintendent/leader must sign this acknowledgement form indicating the charter school's acceptance of the grant award and intention to adhere to the grant requirements.
3. Grant funds for 2021–2022 must be expended by July 31, 2022.
4. The Final Report form for 2021–2022 must be completed and returned to Region 4 no later than August 12, 2022.

Please sign and date this acceptance form and return to my office at Region 4 as soon as possible, but no later than August 13, 2021. Once the form is received, Region 4 will send a check for the entire award amount to the charter school superintendent/leader.
