Purpose and Request:

Recommendation for authorization to execute an interlocal mowing reimbursement agreement with Harris County Municipal Utility District 276 for mowing of HCFCD Units U130-00-00 and U530-01-00 for a term of five mowing seasons. Funds are available in the amount of \$38,224 for five mowing seasons. (Project ID Z100-00-00-V247, Agreement No. 1419, Precinct 4).

Background and Discussion:

The Flood Control District mows three times per year. From time to time, other agencies, such as municipal utility districts, would like to mow areas that the Flood Control District mows more frequently. The Flood Control District uses these types of agreements to commit the local agency to maintaining the channel and/or basin and agrees to pay the local agency the amount of funding the Flood Control District would have paid to mow the areas.

Fiscal Impact: *Funding of \$38,244 is available as part of the Districts Operations and Maintenance Budget.*
