Request by the Sheriff for approval to accept from the Office of the Attorney General of Texas grant funds in the amount of \$118,647, with no required match, for the FY 2022 Statewide Automated Victim Notification Service Program.

Background and Discussion:

This program, funded by the Office of the Attorney General (OAG), pays for continuation of a system that provides automated crime victim information and notification services. Grant funds will be paid to the vendor (Appriss Inc.) selected by OAG. There is no cost to Harris County associated with participation in this program, nor is there a match required.

Expected Impact:

Crime victims will be notified of offender release information and relevant court dates.
