Project includes construction of a standard 4-lane concrete boulevard section on Schiel Road, from East of SH - 99 to West of Fairfield Place Drive.

Change includes installation of temporary 60-inch RCP under driveway:

- REIMBURSEMENT OF COST FOR INSTALLATION OF 60 INCH RCP (\$3,840.00), 0 days
