#### Purpose and Request:

Recommendation for authorization to negotiate an interlocal agreement with Fountainhead Municipal Utility District and Harris County to provide for a joint partnership in support of drainage improvements in the Fountainhead Section 2 Subdivision on HCFCD unit P100-00-00. (Greens Bayou Watershed, Bond ID Z-Subdiv, Project ID P100-00-00-HC022, Precinct 4).

#### **Background and Discussion:**

The Flood Control District Bond Program included 104 subdivision drainage improvement projects to be managed by Harris County Engineering Department's Recovery and Resiliency Division. Many of the subdivision drainage improvement projects will involve partnerships with the utility districts that serve the subdivisions to provide another source of funding. This court item is to allow Harris County and the Flood Control District to develop a funding agreement with the Fountainhead Municipal Utility District to define the financial participation of each party for the proposed drainage project.
