#### **Purpose and Request:**

Recommendation for authorization to initiate and proceed with a feasibility study for drainage improvements along HCFCD Unit P138-00-00. (Greens Bayou Watershed, Bond ID Z-03, Project ID P138-00-00-P001, Precincts 1, 2, and 4). **Background and Discussion:** 

HCFCD unit P138-00-00 is a tributary to Greens Bayou. The channel runs from around West Road and Veterans Memorial east to Greens Bayou near the Lauder stormwater detention basin. IH-45 and the Hardy Toll Road cross the channel. There is an opportunity to work and coordinate with TxDOT and HCTRA on improvements to P138-00-00 as part of drainage improvements to IH-45 and the Hardy Toll Road.
